"MUNICIPAL ORDINANCE NO. 08-14 Series of 2008

PREFATORY STATEMENT

This august body had acted Municipal Ordinance N0. 07-17 entitled "REGULATING THE PASSAGE OF ALL TYPES OF VEHICLES ALONG A PORTION OF RIZAL STREET TRAVERSING SIAYAN CENTRAL SCHOOL" purposely to protect the lives of the school populace and the same to avoid disturbance of class sessions.

However, the Sangguniang Panlalawigan had returned without desired action under Resolution No. 245, Series of 2007 which comments is no penalty for succeeding offense after committed the third offense therefore suggested to be amended.

On the other hand after having reviewed and previous experienced and observance of the implementation of said ordinance it was found that some should be considered for its passage even in time of classes hour as prohibited and regulated particularly during burial wherein the alternate route or road is difficult for the hearse to travel due to its slope, hence this amendments.

BE IT ORDAINED by the Honorable Sangguniang Bayan in Session assembled:

SCETION I. TITLE: This shall be known as "AN ORDINANCE AMENDING SECTION III OF MUNICIPAL ORDINANCE NO. 07-17 SERIES OF 2007, REGULATING THE PASSAGE OF ALL TYPES OF VEHICLES ALONG A PORTION OF RIZAL STREET TRAVERSING SIAYAN CENTRAL SCHOOL".

SECTION II. ORDAINING CLAUSE: That the passage of all types of vehicles at a portion of Rizal Street traversing the Siayan Central School shall be regulated and that no vehicles of all types are allowed to traverse the school area during days with classes on the following time, 7:00 O'clock in the morning up to 5:00 O'clock in the afternoon. All vehicles intent to go to barangay Dumpilas, Sitio Suminalum or to the Municipal Cemetery shall pass through Sabaricos Street and likewise shall apply the same route to all vehicles coming from Dumpilas, Suminalum and the Municipal Cemetery going to Poblacion Siayan.

Any person or group of persons with vehicles whose purpose is not to traverse but up to the school premises only either to have an appointment or transact official business with the Principal, Teachers, Supervisor or Personnel and/or visited their children are allowed to enter the school site and park their vehicles in a duly designated area.

Such person or group of persons shall observe that the presence of their vehicles in the school area will not endanger the safety of the pupils and also it will not disturb the classes and other school activities therein other school activities therein

SECTION III. EXEMPTION: Whenever there is a burial, those vehicles and motorcycles the funeral shall be all the region up to joining the funeral shall be allowed to pass the afore-cited portion of Rizal Street in going up to the cemetery, the same is hereby exempted to the effect of this ordinance.

SECTION IV. PENALTY CLAUSE: That any violators of this ordinance shall be penalized in the following manner:

1st Offense

- P 500.00

2nd Offense

1,000.00

3rd and succeeding offenses

2,000.00 and/or imprisonment of 30 days

but not more than 60 days or at the discretion of the Court.

SECTION V. SEPARABILITY CLAUSE: That Ordinance No. 07-17 Series of 2007 is hereby repealed and modified as amended

SECTION VI. EFFECTIVITY: That this Ordinance shall take effect 30 days and posting of copies at a conspicuous places and publish in official gazette.
