"MUNICIPAL ORDINANCE NO. 08-15
Series of 2008

PREFATORY STATEMENT

The Poblacion of Siayan, Zamboanga del Norte have several public market buildings located along Benlot, Alumbre, Adaza and Siasico Streets. One building is primarily intended for vendors displaying and selling fresh fish, other sea foods and also meat. Another building is used as the dried fish section. This practice had been done for several years which make the public market and its premises clean, sanitary and orderly.

For the past few months however, it had been observed that there are some fish vendors/peddlers some of them on their motorcycles selling and displaying fresh and dried fish along the afore-cited streets which make the area unsanitary.

To maintain the cleanliness, orderliness and proper sanitation as well as the beauty of the said municipal streets there is a need to prohibit vendors/peddlers to sell fresh and dried fish and other sea foods in this area of Poblacion, Siayan.

BE IT ORDAINED by the Honorable Sangguniang Bayan in session assembled:

SECTION I. TITLE: That this Ordinance shall be known as "AN ORDINANCE PROHIBITING FISH VENDORS/PEDDLERS WITH THEIR MOTORCYCLES TO SELL OR DISPLAY FRESH OR DRIED FISH AND OTHER SEA FOODS IN THE VICINITY OF THE PUBLIC MARKET PARTICULARLY AT BENLOT, ALUMBRE, ADAZA AND SIASICO STREETS.

SECTION II. ORDAINING CLAUSE:

- a) That the selling/displaying of fresh and dried fish and other sea foods in the vicinity of the public market particularly at Benlot, Alumbre, Adaza and Siasico Streets is hereby prohibited.
- b) Vendors/peddlers who intent to sell/display their fresh and dried fish including other sea foods shall occupy a table or stall inside the public market provided however they must pay the required cash tickets or taxes thereof.

SECTION III. PENALTY CLAUSE: Any person or group of persons who violate this Ordinance shall suffer the following penalty:

| 2 nd Offense | - Fine of P500.00 |
| 3 rd and succeeding offenses | - A fine of P1,000.00 and/or an imprisonment of 5 days but not more than 10 days at the discretion of the court. |


SECTION VI. EFFECTIVITY: That this Ordinance shall take effect 30 days and posting of copies at a conspicuous places and publish in official gazette.
