AN ORDINANCE CONSOLIDATING AND PROGRAMMING LUMPED CONTINUING APPROPRIATIONS
IN CAPITAL OUTLAYS, 20% EDF AND CURRENT APPROPRIATIONS CY 1998 IN THE 20%
PER EO # 98-02 FOR PURCHASE OF WHEEL LOADER AND DUMP TRUCKS AND ITS MAIN-
TENANCE.

PREFATORY STATEMENT

The Local Government Unit of Siayan in its vision to connect all barangays
with good and all weather roads resorted to borrowings from PNB-Sindangan
in order to purchase wheel loader and dump trucks to augment the performance
of newly acquired bulldozer. Due to the recurring economic crisis and the
continuous fluctuation of peso value, the amount originally appropriated
for the purchase of aforementioned equipment was short of its actual cost
despite additions of appropriations as authorized in Ordinance No. 02
current series. To be able to meet obligations and other incidental ex-
penditures related to the equipments mobility and maintenance it is but
necessary to appropriate more funds for the purpose. However, the Local
Government has no other recourse but to lump all savings of completed pro-
jects in the 20% EDF and Capital Outlay as well as to reprogram some pro-
jects in the current year's 20% fund.

BE IT ORDAINED by the Sangguniang Bayan of Siayah, Zamboanga del Norte
in session assembled:

SECTION I. TITLE: This ordinance shall be entitled and be known as
"ORDINANCE CONSOLIDATING AND PROGRAMMING LUMPED CONTINUING APPROPRIATIONS
IN THE 20% EDF, CAPITAL OUTLAYS AND CURRENT YEAR'S 20% EDF" for the pur-
chase of wheel loader, dump trucks and its maintenance.

SECTION 2. ORDAINING CLAUSE: That the lumped amount shall be appropria-
ted for the purchase of wheel loader, dump trucks and its maintenance which
amounted to ₱1,275,198.41, sourced from:
