SECTION VI. MISCELLANE OUS PROVISIONS. The fine collected from any violators state be paid to the Municipal Treasurer, likewise said personnel or her/his duly authorized representative state issue the corresponding official receipt and the funds shall be accounted as penalty of this Ordinance.

SECTION VII. EFFECTIVITY. This Ordinance shall take effect 60 days after approval of the Sangguniang Panlalawigan and posting of copies at conspicuous places and publication of official gazette.

***** Firstly, Hon. Estrella S. Zapatos moved for its approval, however, Hon. Felizardo I. Gayapa Sr. expressed his opposition particularly on Section IV which is the penalty clause.

Hon. Gayapa was not in favored on the statement in Section IV, shown aboved, particularly the word "outside" exemplifying that any person smoking outside the vicinity of the smoking area even walking along the road within barangay poblacion shall be penalized. Therefore he introduced amendment to be stated:

"Any violation of this ordinance shall be penalized based on the following offense"

The same time, Hon. Rudy S. Dominise on his opinion revealed that the main topic of the ordinance was designating a smoking area, thus it is appropriate that outside of the vicinity of the smoking area is a violation of the ordinance, however, the area where the ordinance shall be enforced is specific within the municipal hall complex and public market premises only.

On the other hand, Hon. Estrella S. Zapatos made mentioned that Hon. Felizardo Gayapa Sr. was against on this ordinance and she said what the latter wants is to designate the non-whoking area not the whoking area, thereby any person are free to smoke outside of the identified non-smoking area.

Instantly, Hon. Oliver A. Romero moved that said measure be made pending for further study superseding the main motion to approved and the amendments introduced considering that some members were not reconciled on their ideas, no objection thus the motion was carried.

MEASURES CONSIDERED AND APPROVED IN THE PREMISE OF SECOND READING WITHOUT FURTHER DISCUSSIONS AND AMENDMENTS ARE QUOTED HEREUNDER:

"MUNICIPAL ORDINANCE NO. 05-08 Series of 2005

PREFATORY STATEMENT

Municipal Ordinance Nos. 02-005, Series of 2002 and 05-005, Series of 2005 was both effecting the temporary closure of the two (2) old market buildings for renovation/repair purposes.

The two (2) old market buildings above-mentioned upon its renovation/repair initiated by the Municipal Engineering Office were found that all parts from its floorings, walls and roofing were totally dilapidated which unnecessary to be renovated/repair, thus, the Local Government Unit decided to demolished such buildings, consequently construction of a new ones.

The statement "Renovation/Repair" mentioned in Ordinance No. 02-005, Series of 2002 and Ordinance No. 05-005, Series of 2005 is inappropriate since the actual works resulted to the total demolition and construction of new market buildings.

This ordinance is hereby acted to write-off the two (2) demolished old market buildings in the assets of the Book of Accounts of the Local Government Unit in conformance with auditing and recording of funds utilized.

BE IT ORDAINED by the Sangguniang Bayan in session assembled:

SECTION 1. TITLE. This Ordinance shall be known as "An Ordinance Effecting the Demolition of Two (2) old Market Buildings Likewise the Construction of New Market Building for its Replacement Located at the Same Site of Poblacion, Siayan, ZN. Amending Municipal Ordinance No. 02-005 and No. 05-005".

SECTION II. ORDAINING CLAUSE. The two (2) old market buildings located within the public market at Poblacion, Sisyan, Zamboanga del Norte particularly in front of the fish vendor building along Adaza Street and in between along Adaza and Beniot Street shall be demolished, consequently effect the construction of new market buildings for its replacement.

SECTION III. ADMINISTRATIVE PROVISION. The two old market buildings being demolished shall be written-off in the assets of the book of accounts of the Local Government Unit.

SECTION IV. FEPEALING CLAUSE. Municipal Ordinance No. 02-005, Series of 2002 and Municipal Ordinance No. 05-005 are hereby repealed.

SECTION V. EFFECTIVITY. This Ordinance shall take effect upon approval by the Hon. Sangguniang Panlalawigan of Zamboanga del Norte.
