"MUNICIPAL ORDINANCE NO. 06-08
Series of 2006

PREFATORY STATEMENT

Elective officials, unlike appointive officials and employees do not enjoy incentives/benefits such as productivity, salary step increments and other personnel compensation like Personnel Relief Allowance (PERA). It is so anchored in this aspect the appropriateness of granting an exemplary service award to elective officials who have served three (3) consecutive terms of any elective position. The award be in a form of cash incentive chargeable against local funds as token for the long service, the most fitted service in the arena of politics.

As provided under Sec. 447, sub par. (viii), the Sangguniang Bayan is empower to determine the salaries, wages, allowances and other emoluments and benefits of officials and employees paid wholly or mainly from municipal funds and provide for expenditures necessary for the proper conduct of programs, projects, services and activities of the municipal government, provided however such appropriations shall be incorporated in the Annual Budget in conformance to the usual accounting and auditing rules and procedures and other budgeting parameters;

BE IT ORDAINED by the Honorable Sangguniang Bayan in session assembled:

SECTION I. TITLE – This ordinance shall be entitled "AN ORDINANCE AUTHORIZING THE GRANT OF EXEMPLARY PUBLIC SERVICE AWARD TO MUNICIPAL ELECTIVE OFFICIALS WHO HAVE SERVED THREE (3) CONSECUTIVE TERMS IN THE SAME OR ANY OTHER ELECTIVE POSITIONS IN THE LOCAL GOVERNMENT UNIT OF SLAYAN, ZAMBOANGA DEL NORTE."

SECTION II. DEFINITION OF TERMS:

MUNICIPAL ELECTIVE OFFICIALS – obtained or bestowed by election or pertaining to a choice by vote namely: Municipal Mayor, Municipal Vice Mayor and eight (8) Sangguniang Bayan members,

CONSECUTIVE – following in uninterrupted succession, successive,

TERM – a term of office is fixed period or definite length of time,

GRANT – to confer or bestowed as a privilege,

EXEMPLARY – services or fitted to serve as a model or example of worthy of limitation; commendable,

SERVICES – duty or work rendered by one person to another,

AWARD – a prize that which is awarded,

SECTION II. ORDAINING CLAUSE: All Municipal Elective Officials, such as Municipal Mayor, Municipal Vice Mayor and eight (8) Sangguniang Bayan members of this municipality who rendered exemplary services having served three (3) consecutive terms without records of disciplinary action, criminal conviction, or violation of any law or regulations is hereby eligible to received and incentive cash awards equivalent to the totality of six (6) months salary of the present position, exclusive of any other remuneration such as bonuses, representation and transportation allowance, or any other emoluments or income which he/she may have earned by virtue of his office.

In addition to the foregoing, a plaque of appreciation/recognition shall also be awarded to the aforesaid municipal elective officials who qualify for the three (3) term of service award herein provided in appropriate ceremonies.

SECTION III – ADMINISTRATIVE PROVISION: The exemplary incentive cash award to elective local officials herein authorized shall be appropriated in the next Annual Budget CY 2007 and year thereafter.

Any elective officials who has served a two term in a lower and/or higher position and the third term in another lower and/or higher position shall be qualified to the incentives award provided herein,


SECTION VII. SEPARABILITY CLAUSE – In the event that any of the provisions of this ordinance is declared unconstitutional, and illegal or void the validity of the other provisions shall not be affected by such declaration.


SECTION IV. EFFECTIVITY CLAUSE – This Ordinance shall take effect upon its approval.




Since there being no further business before the Honorable Sangguniang Bayan in session assembled thus the Chair declared session adjourned at 5:00 O'clock in the afternoon.


