

**"MUNICIPAL ORDINANCE NO. 05-10

PREFATORY STATEMENT

Municipal Ordinance No. 99-07 known as the Rabies Prevention Control Ordinance is mandating the owners to register/license their pet dog aging from 3 months and prior to its registration/licensing the dog shall undergo rabies vaccination administered by the Municipal Rabies Control Authority.

The expenses of vaccines and other medicines needed in vaccination of dogs shall be borne by the Local Government Unit. Other than the vaccination cost, the Municipal Rabies Control Authority will provide dog tag as sign of vaccinated and registered/licensed dogs which is additional expenses of the LGU.

Unfortunately, Section VI of Municipal Ordinance No. 99-07 was imposing a dog registration/licensing fees and/or charges in the amount of P20.00 per head, which is minimal compared to the expenses incur of vaccination requirements, stated hereunder:

SECTION VI. DOG REGISTRATION OR LICENSING: Every dog shall be registered by their owner upon reaching the age of 3 months and every year thereafter. Unvaccinated dogs registered after reaching the age of 3 months and dogs 3 months old and above not previously registered shall be vaccinated upon registration. The dog owner shall pay such registration fee as determined by the Finance Committee approved by the Sangguniang Bayan at the rate of Twenty Pesos (P20.00) per head. The registration officer shall provide the owner with a certificate of registration for the dog and affix to its distinguishing collar tag as proof of registration.

In fairness with the owners and the Local Government Unit, the imposition of fees and or charges reflected under Section VI of Ordinance No. 99-07 shall be amended, hence this ordinance

BE IT ORDAINED by the Sangguniang Bayan in session assembled:

SECTION I. TITLE. This Ordinance shall be known as "AN ORDINANCE AMENDING SECTION VI OF MUNICIPAL ORDINANCE NO. 99-07 SPECIFICALLY THE FEES AND/OR CHARGES IN THE REGISTRATION/LICENSING OF DOG".

SECTION II. ORDAINING CLAUSE. The amount of P20.00 pesos imposed as fees and/or charges of dog registration/licensing reflected under Section VI of Municipal Ordinance No. 99-07 is hereby amended, and the amount of P100.00 shall be collected.

SECTION III. MISCELLANEOUS PROVISIONS. This Ordinance is form part of the Municipal Revenue Code of Siayan, Zamboanga del Norte.

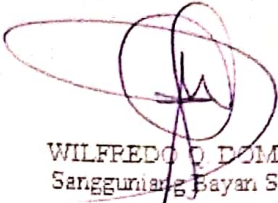
SECTION IV. REPEALING CLAUSE. The fees and/or charges in the amount of Twenty (P20.00) under Section VI of Municipal Ordinance No. 99-07 is hereby repealed and modified accordingly.

SECTION V. EFFECTIVITY. This ordinance shall take effect upon approval of the Hon. Sangguniang Panlalawigan of Zamboanga del Norte.

Since there being no further business before the Honorable Sangguniang Bayan in session assembled thus the Chair declared session adjourned at 5:00 O' clock in the afternoon

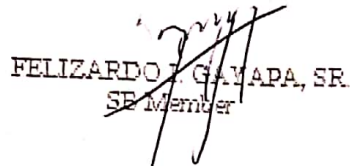
