***APPROPRIATION ORDINANCE NO. 18-09**

APPROPRIATION ORDINANCE MAKING AVAILABLE THE AMOUNT OF THREE MILLION THIRTY SIX THOUSAND (PHP3,036,000.00) PESOS FOR THE GRANT OF COLLECTIVE NEGOTIATION AGREEMENT (CNA) INCENTIVES OF THE LOCAL OFFICIALS AND EMPLOYEES OF THE LOCAL GOVERNMENT UNIT OF SIAYAN, ZAMBONGA DEL NORTE.

PREFATORY STATEMENT

WHEREAS, the Local Finance Committee had certified to the availability of the accumulated surplus sourced from the MOOE allotment FY 2018 after closing the Book of Accounts of the Municipal Government of Slayan, Zamboanga del Norte amounting to THREE MILLION THIRTY SIX THOUSAND (PHP3,036,000.00) PESOS.

WHEREAS, the Department of Budget and Management (DBM) has issued Budget Circular No. 2018-5, dated November 14, 2018, subject of which is the "Guidelines on the Grant of Collective Negotiation Agreement (CNA) Incentive for FY 2018".

BE IT ORDAINED by the Sangguniang Bayan in session assembled:

SECTION I. TITLE: This ordinance shall be known as an "APPROPRIATION ORDINANCE MAKING AVAILABLE THE AMOUNT OF THREE MILLION THIRTY SIX THOUSAND (PHP3,036,000.00) PESOS PESOS FOR THE GRANT OF COLLECTIVE NEGOTIATION AGREEMENT (CNA) INCENTIVES OF THE LOCAL OFFICIALS AND EMPLOYEES OF THE LOCAL GOVERNMENT UNIT OF SIAYAN, ZAMBONGA DEL NORTE.

SECTION II. ORDAINING CLAUSE: The Collective Negotiation Agreement (CNA) incentives FY 2018 is hereby granted to the Local Officials and qualified employees of the Local Government Unit in the amount of TWENTY THREE THOUSAND (PHP23,000.00) PESOS each.

SECTION III. FUNDING SOURCE: The CNA Incentive granted herein is sourced from the MOOE Allotments FY 2018 amounting to THREE MILLION THIRTY SIX THOUSAND (PHP3,036,000.00) PESOS.

SECTION IV. EFFECTIVITY: This Ordinance shall take effect upon approval.
