MUNICIPAL ORDINANCE NO. 98-09 Series of 1998

AN ORDINANCE PROHIBITING ANY PERSON OR GROUP OF PERSONS TO USE THE MUNICIPAL OUTDOOR PLAYING COURT AT POBLACION, SIAYAN, ZAMBDANGA DEL NORTE IN DRYING ANY AGRICULTURAL PRODUCTS.

## PREFATORY STATEMENT

As observed, the municipal outdoor playing court is intended for playing basketball, volleyball, tennis, etc, was often seen to have been used in drying any agricultural products.

Sports enthusiast often complained that their playing convenience have been hampered because of using the court in drying any farm products. The outdoor playing court is a public property that needs to be maintained and preserved for its purpose.

SECTION I. TITLE - This ordinance shall be known as an ordinance prohibiting any person or group of persons to use the municipal outfloor playing court at Poblacion Siayan, Zamboanga del Norte in drying any agricultural products.

SECTION II. Regulated Acts. No person shall use the municipal cutdoor playing court at Poblacion Siayan, Zamboanga del Norte in drying any agricultural products.

SECTION III. Penal provision any person who violates thereof shall be penalized by a fine of not more than two hundred (\$200.00) pesos or imprisonment of not more than five (5) days or both fine and imprisonment at the discretion of the honorable court.

SECTION IV. Effectivity Clause - This Ordinance shall take effect 30 days upon its approval, publication and posting at conspicous places.
