MUNICIPAL ORDINANCE NO. 99-09
Series of 1999

AN ORDINANCE MAKING AVAILABLE THE AMOUNT OF THIRTY EIGHT MILLION THREE HUNDRED THOUSAND (P38,300,000.00) PESOS AS ANNUAL BUDGET FOR CY-2000.

BE IT ORDAINED by the Honorable Sangguniang Bayan of Siayan, Zamboanga del Norte in session assembled:

PREFATORY STATEMENT

After the local finance committee has convened to deliberate on the estimated resources probable for collection in the year 2000. They came up with certification that THIRTY EIGHT MILLION THREE HUNDRED THOUSAND (P38,300,000.00) PESOS may be probably collected. The same amount shall be the total annual estimate available for appropriations to various expenditures of the municipality in its operations and governance.

SECTION I - TITLE: This Ordinance shall be entitled "ORDINANCE MAKING AVAILABLE THE AMOUNT OF THIRTY EIGHT MILLION THREE HUNDRED THOUSAND (P38,300,000.00) PESOS AS ANNUAL BUDGET FOR CY-2000".

SECTION II - That the amount shall hereby be made available for expenditure embodied in the General Fund for CY-2000.

SECTION III - EFFECTIVITY: That this ordinance shall take effect on January 1, 2000.
