Series of 2007

PREFATORY STATEMENT

It is observed that many minors of today's generation are indulge in bad habits and vices like smoking cigarettes and drinking liquor and other alcoholic drinks. These bad practices among minors will profoundly destroy their young lives, their hopes and future and not only that, it will also lead them to commit acts of lawlessness such as robbery, stealing and other forms of crimes.

It had been noted and observed that some of these minors are students who used their hard-earned school allowance for buying cigarettes and liquor, thus if it will remain unchecked will really affect their good future.

To prohibit vendors, store owners and business establishment proprietors to sell cigarettes, liquors and other forms of alcoholic drinks to minors especially students eventually control, minimize check-up their vices. These minors especially students will devote more times and efforts for their studies and other sports and livelihood activities thereby decreasing and controlling some acts of juvenile delinquency.

BE IT ORDAINED by the Sangguniang Bayan in session assembled:

SECTION I – TITLE. That this Ordinance shall be known as "AN ORDINANCE PROHIBITING VENDORS, STORE OWNERS AND BUSINESS ESTABLISHMENT/PROPRIETORS TO SELL CIGAR/CIGARETTES, LIQUOR AND ALL KINDS OF ALCOHOLIC DRINKS TO ALL MINORS WITHIN THE TERRITORIAL JURISDICTION OF THE MUNICIPALITY OF SIAYAN".

SECTION II – ORDAINING CLAUSE. That all VENDORS, STORE OWNERS AND BUSINESS ESTABLISHMENT/PROPRIETORS PROHIBIT TO SELL CIGAR/CIGARETTES, LIQUOR AND ALL KINDS OF ALCOHOLIC DRINKS TO ALL MINORS WITHIN THE TERRITORIAL JURISDICTION OF THE MUNICIPALITY OF SIAYAN".

SECTION III – PENALTY CLAUSE. That any violators of this ordinance shall be penalized in the amount of P1,000.00 but not more than P2,000.00 and/or imprisonment of 30 days but not more than 60 days or at the discretion of the honorable court.

SECTION IV – EFFECTIVITY CLAUSE. That this ordinance shall take effect upon its approval.
