"APPROPRIATION ORDINANCE NO. 11-09 Series of 2011

PREFATORY STATEMENT

The Local Finance Committee has certified the availability of funds amounting to TWO MILLION REE HUNDRED THIRTY SEVEN THOUSAND NINE HUNDRED SIXTY SIX PESOS (PhP 2,337,966.00) irced from IRA difference FY 2011 which is free of any encumbrances and subject for budgeting to cater the ious expenditures of the local government unit of this municipality.

BE IT ORDAINED by the Sangguniang Bayan in session assembled:

SECTION I. TITLE. This shall be known as "AN APPROPRIATION ORDINANCE MAKING AVAILABLE E AMOUNT OF TWO MILLION THREE HUNDRED THIRTY SEVEN THOUSAND NINE HUNDRED SIXTY PESOS (PhP 2,337,966.00) SOURCED FROM IRA DIFFERENCE FY 2011 EMBODIED IN PPLEMENTAL BUDGET NO. 3 FY 2011 FOR VARIOUS EXPENDITURES OF THE LOCAL GOVERNMENT IT OF SIAYAN, ZAMBOANGA DEL NORTE".

SECTION II. ORDAINING CLAUSE. That the amount of TWO MILLION THREE HUNDRED THIRTY VEN THOUSAND NINE HUNDRED SIXTY SIX PESOS (PhP 2,337,966.00) is hereby made available for ious expenditures of the local government unit. Statement of Supplemental Appropriation (LBP Form N0.10) rereto attached as form part of this ordinance.

SECTION III. EFFECTIVITY. That this ordinance shall take effect upon the approval of the Sangguniang plalawigan of Zamboanga del Norte.
