DECLARING IN ORDER ORDINANCE NO. 01 OF GUNYAN AND THE ANNUAL BUDGET FY 2010 BE DEEMED OPERATIVE EFFECTIVE JANUARY 1, 2010.

WHEREAS, submitted before this august body for review and favorable action was Ordinance No. 01 of the Sangguniang Barangay of Gunyan authorizing for the passage of Annual Budget FY 2010 with an estimated income of P1,120,960.00;

WHEREAS, review made on the budget disclosed that the programs and projects incorporated therein conform to those identified in the approved plan as mandated under Section 305 of RA 7160;

WHEREAS, Personal Services Cap had been exceeded per computation as follows:

Total Income Realized	- 817,667.47
PS limitation	x 55%
Allowable PS level	- 449,717.10
PS Cost of existing personnel as of last reviewed budget – Annual	- 527,603.70
Excess in PS Cost	P (77,886.60)

WHEREFORE, premise considered and on motion of Hon. Ephraim O. Melindo, duly seconded by all members present, it was

RESOLVED, as this body hereby resolved to declare in order Ordinance No. 01 Series of 2010 of the Sangguniang Barangay of Gunyan, provided it shall strictly observed the Personal Services (PS) expenditure limitations as prescribed under LBC No. 75 and Section 325 (a) of RA 7160.

"MUNICIPAL ORDINANCE NO. 10-02
Series of 2008

PREFATORY STATEMENT

Rubber cement is an adhesive made from elastic polymers mixed in a solvent such as acetone, heptane or benzene to keep them fluid enough to be used. The chemical content of rubber cement is intoxicated and/or addictive substance which is very dangerous by sniffing it and the effects result to lung damage and slowly result to physical deterioration.

Most likely in the municipality of Siayan, some youths, teenager both high school and elementary students were noted indulging themselves by sniffing rubber cement publicly known as **RUGBY**, which is very dangerous to their health and be addictive to the said material.

To stop, prevent and/or minimize the practice of these youths to indulge in sniffing rugby (rubber cement), hence this precautionary measure.

BE IT ORDAINED by the Honorable Sangguniang Bayan in session assembled:

SECTION I. TITLE. This shall be known as "AN ORDINANCE PROHIBITING VENDORS, STORE OWNERS AND BUSINESS ESTABLISHMENTS PROPRIETORS TO SELL RUBBER CEMENT (RUGBY) TO ALL MINORS WITHIN THE TERRITORIAL JURISDICTION OF THE MUNICIPALITY OF SIYAN, ZAMBOANGA DEL NORTE.

SECTION II. ORDAINING CLAUSE. That all vendors, store owners, business establishments selling rubber cement (rugby) within the jurisdiction of the municipality of Siayan, Zamboanga del Norte is hereby prohibited to sell Rubber Cement (rugby) to all minors aging 18 years old below.

SECTION III. PENAL PROVISION. Any proprietor or storeowner, business establishments herein that violating this ordinance shall be penalized in the following manner:

SECTION IV. EFFECTIVITY. This ordinance shall take effect upon approval.




