## "MUNICIPAL ORDINANCE NO. 00-10 Series of 2000

MUNICIPAL ORDINANCE CREATING THE POSITION OF AGRICULTURAL TECHNOLOGIST, SALARY GRADE 10 IN THE MUNICIPAL AGRICULTURAL OFFICE OF THE LOCAL GOVERN-MENT UNIT OF SIAYAN AND INCLUSING THE SAME IN THE MUNICIPAL ORGANIZATIONAL CHART AND STAFFING PATTERN AND PLANTILLA OF PERSONNEL FOR FUNDING ALLOCATION CY 2001.

BE IT ORDAINED by the Honorable Sangguniang Bayan of Siayan, Zamboanga del Norte in session assembled:

SECTION I. TITLE - This Ordinance shall be known as "An Ordinance creating the position of Agricultural Technologist, Salary Grade 10 in the Municipal Agriculture Office, of the Local Government Unit of Siayan, Zamboanga del Norte.

SECTION II. POLICY STATEMENT - That the position herein mentioned shall be occupied and/or filled up in accordance to the qualification standard and/or Civil Service Laws, rules and regulations.

SECTION III. ORDAINING CLAUSE - That the position of Agricultural Technologist, Salary Grade 10 in the Municipal Agriculture Office is hereby created and inclusing the same in the Municipal Organizational Chart and Staffing Pattern and Plantilla of Personnel for funding allocation CY 2001 in the Local Government Unit of Siayan, Zamboanga del Norte.

SECTION IV. EFFECTIVITY CLAUSE - That this Ordinance shall take effect 30 days after approval.
