The regular session was called to order by the Hon. Presiding Officer Hon. Municipal Vice Mayor Ephraim O. Melindo at 8:00 O'clock in the morning. It was opened with a prayer led by Hon. Samuel G. Baculpo, Sr.

Then the chair declared quorum after calling the roll, since all Sangguniang Bayan members were present.

Minutes of the previous regular session was read and the same were stand approved as read without corrections, moved by Hon. Oliver A. Romero, duly seconded by Hon. Daisy A. Limbang, Hon. Samuel G. Baculpo, Sr., Hon. Inocencio A. Limbang and Hon. Estrella S. Zapatos.

Since no one took the privilege hour thus proceeded to the first reading of the different measures entered in the reference of business therefore referred and assigned to concerned committees for study however item No. 1 was moved to be treated as urgent after the rule in the order of business was suspended temporarily moved by Hon. Rudy S. Dominise, stated hereunder:

1. AN APPROPRIATION ORDINANCE MAKING AVAILABLE THE AMOUNT OF THREE MILLION FOUR HUNDRED NINETY THOUSAND NINE HUNDRED THIRTY PESOS AND SIXTY SEVEN CENTAVOS (PHP 3,490,930.67) EMBODIED IN SUPPLEMENTAL BUDGET NO. 2 CY 2006 FOR VARIOUS EXPENDITURES OF THE LOCAL GOVERNMENT UNIT.

Premise of the foregoing discussions and deliberation, the above-measures were considered and approved without amendments, quoted hereunder:

PREFATORY STATEMENT

The Finance Committee has certified to the availability of funds in the amount of P3,490,930.67 sourced from the monetized IRA of the previous years which is free of any encumbrances or obligations whatsoever subject for appropriation embodied in Supplemental Budget No. 02 to defray various expenditures in the operation of the local government unit of this municipality, hence this ordinance.

BE IT ORDAINED by the Sangguniang Bayan in session assembled:

SECTION I. TITLE: This shall be known as "AN APPROPRIATION ORDINANCE MAKING AVAILABLE THE AMOUNT OF THREE MILLION FOUR HUNDRED NINETY THOUSAND NINE HUNDRED THIRTY PESOS AND SIXTY SEVEN CENTAVOS (PHP3,490,930.67) EMBODIED IN SUPPLEMENTAL BUDGET NO. 2 CY 2006 FOR VARIOUS EXPENDITURES OF THE LOCAL GOVERNMENT UNIT".

SECTION II. ORDAINING CLAUSE: That the amount of P3,490,930.67 embodied in Supplemental Budget No. 2 CY 2006 is hereby made available to defray the following expenditures, attached hereto is Local Budget Preparation Form No. 152 and the program 20% which is form part of this ordinance.

SECTION III. EFFECTIVITY. That this ordinance shall take effect upon approval of the Sangguniang Panlalawigan of Zamboanga del Norte.

1. RESOLUTION AUTHORIZING THE MUNICIPAL TREASURER MRS. FLORES C. BAYNOSA TO PAY THE TRAVELLING ALLOWANCES AND PERDIEMS OF MR. RODRIGO M. SIASICO JR. AND MRS. NELIA S. SIASICO WHILE ATTENDING THE 2ND PROVINCIAL PARENTING FORUM ON SEPTEMBER 25-26, 2008 AT ZAMBOANGA DEL NORTE CONVENTION AND EXHIBITION CENTER, DIPOLOG CITY PER LETTER OF OIC PSWDO MARYLEN B. SABAL DATED SEPTEMBER 4, 2008 ADDRESS TO THE HON. MAYOR ABUNDIO A. SIASICO JR. (Referred to the Committee on Finance)

After its referral, it was followed by Committee reports.

First reporter was the Committee on Public Works through the Chairman Hon. Felizardo I. Gayapa, Sr. to which was referred on:

1. RESOLUTION NO. 15 OF DIONGAN SERIES OF 2008 REQUESTING HON. ISMAEL ARASAM TO APPROPRIATE FUNDS FOR THE PURCHASE OF ONE UNIT WATER DISPENSER WITH ONE GALLON PURIFIED WATER FOR THE USE OF BARANGAY HALL.

FINDINGS:

- a) Water dispenser is the cheapest way of dispensing potable water for drinking specially those purified one.
- b) The barangay officials during the conduct of meetings, conferences and sessions is in need of supply of safe and potable drinking water especially with the presence of water dispenser.
- c) Water dispenser with purified water to be established in the barangay hall would help serving people having daily transactions thereat.
- d) Due to lack of funds the barangay council of Diongan through Resolution No. 15 request financial assistance through the Provincial Federation Association of Barangay Captain President Hon. Ismael Arasam for the purchase of water dispenser and one (1) gallon purified water chargeable against its provincial identification fund.

The committee recommends for inclusion in second reading for proper disposition. The committee's recommendation was adopted.

Second reporter was the Committee on Finance through the Chairman Hon. Rudy S. Dominise to which were referred, as follows:

1. RESOLUTION NO. 16 OF DIONGAN SERIES OF 2008 REQUESTING HON. VICE MAYOREPHRAIM O. MELINDO, HON. DAISY A. LIMBANG, HON. INOCENCIO A. LIMBANG TO APPROPRIATE FUND FOR THE CONSTRUCTION OF GUEST HOUSE.
2. RESOLUTIONH NO. 17 OF DIONGAN SERIES OF 2008 REQUESTING HON. ABUNDIO A. SIASICO JR. THROUGH SANGGUNIANG BAYAN MEMBERS TO ALLOCATE FUNDS UNDER MUNICIPAL IDENTIFICATION FUND (MIF) IN THE AMOUNT OF TWENTY ONE THOUSAND FOUR HUNDRED FIFTY PESOS (P21,450.00) FOR THE CONSTRUCTION OF ONE ROOM. DIONGAN NATIONAL HIGH SCHOOL, DIONGAN, SIAYAN, ZAMBOANGA DEL NORTE.
3. RESOLUTION NO. 08 OF DUMPILAS SERIES OF 2008 REQUESTING THE LGU THRU THE HON. MUNICIPAL MAYOR AND THE MUNICIPAL SANGGUNIANG BAYAN MUNICIPALITY OF SIAYAN, ZAMBOANGA DEL NORTE AN AMOUNT OF P10,000.00 FROM THERE MIF, AN ASSISTANCE OF WAITING SHADE, LOCATED AT BRGY SITE, DUMPILAS, SIAYAN, ZAMBOANGA DEL NORTE.

WHEREFORE, premise considered and on motion of Hon. Rudy S. Dominise duly seconded by all members present, it was




Since there being no further business before the Honorable Sangguniang Bayan in session assembled thus the Chair declared session adjourned at 5:00 O'clock in the afternoon.


