PREFATORY STATEMENT

The Finance Committee has certified to the availability of funds in the amount of P932,852.84 sourced from the un-appropriated balance in the general fund per Supplemental Budget No. 02 CY 2007 which is free of any encumbrances or obligations whatsoever subject for appropriation embodied in Supplemental Budget No. 03 CY 2007 to defray various expenditures in the operation of the Local Government Unit of this municipality, hence this ordinance.

BE IT ORDAINED by the Sangguniang Bayan in session assembled:

SECTION I. TITLE: This shall be known as "AN APPROPRIATION ORDINANCE MAKING AVAILABLE THE AMOUNT OF NINE HUNDRED THIRTY TWO THOUSAND EIGHT HUNDRED FIFTY TWO PESOS & EIGHTY FOUR CENTAVOS (P932,852.84) EMBODIED IN SUPPLEMENTAL BUDGET NO. 03 CY 2007 FOR VARIOUS EXPENDITURES OF THE LOCAL GOVERNMENT UNIT".

SECTION II. ORDAINING CLAUSE: That the amount of P932,852.84 embodied in Supplemental Budget No. 03 CY 2007 is hereby made available to defray the following expenditures, reflected in different LBP Form No. 161-A, and LBP No. 152 hereto attached as form part of this Ordinance.

1. Construction of Drainage Canal	P 300,000.00
2. Rubber Nursery Establishment	232,852.84
3. Maint. of Roads and Bridges	200,000.00
4. Maint. of Gov't. Facilities & Buildings	<u>200,000.00</u>
TOTAL =====	P 932,852.84

SECTION III. EFFECTIVITY. That this ordinance shall take effect upon approval of the Sangguniang Panlalawigan of Zamboanga del Norte.
