AN ORDINANCE MAKING AVAILABLE THE AMOUNT OF THIRTY EIGHT MILLION FOUR HUNDRED THIRTY THOUSAND TWO HUNDRED SEVENTY (P38,430,270.00) PESOS AS ANNUAL BUDGET OF THE GENERAL FUND FOR CALENDAR YEAR 2001 OF THE LOCAL GOVERNMENT UNIT OF SIAYAN, ZAMBOANGA DEL NORTE.

PREFATORY STATEMENT

After the Local Finance Committee has convened to deliberate on the estimated resources probable for collection in the year 2001, they certified that the amount of P38,43,270.00 is probable. The same amount shall be available for appropriations to various expenditures of the municipality in the operations and governance.

BE IT ORDAINED by the Honorable Sangguniang Bayan in session assembled:

SECTION I. TITLE. That this ordinance shall be known as "An ordinance making available the amount of P38,430,270.00 embodied in the Annual Budget for CY 2001 for various expenditures of the Local Government Unit of Siayan, Zamboanga del Norte"

SECTION II. ORDAINING CLAUSE. That the amount of P38,43,270.00 in General Fund is hereby made available for various expenditures CY 2001.

SECTION III. EFFECTIVITY CLAUSE. That this ordinance shall take effect on January 1, 2001.
