PREFATORY STATEMENT

The Local Government Unit of this municipality accumulated the amount of P462,515.58 sourced from the lump continuing appropriation FY 2007 which was allotted/appropriated of different functions, programs, projects and activities embodied in Status of Allotments and Obligations Form (Continuing Appropriation) and the amount of P20,000.00 of the Capital Outlay of the PNP for fabrication of Arm Rack found under the Status of Appropriations, Allotments and Obligations Form (Current Legislative Appropriation) and both is hereto attached as form part of this enactment.

The enumerated programs, projects and activities above-mentioned are no longer of priority importance compare to the present urgent needs of the office concerned which is gasoline, oil and lubricants for the service vehicles and heavy equipments in the implementation of vertical and horizontal projects undertaken by the this local government, and likewise arm rack is no longer priority for the PNP rather than a digital camera to cover crime scenes and other activities of the law enforcers which requires pictorials documentations.

BE IT ORDAINED by the Hon. Sangguniang Bayan in session assembled:

SECTION I. TITLE. This shall be known as "AN ORDINANCE REPROGRAMMING THE AMOUNT OF P462,515.58 SOURCED FROM THE LUMP CONTINUING APPROPRIATION FY 2007 FOR THE PURCHASE OF GASOLINE, OIL AND LUBRICANTS AND THE AMOUNT OF P20,000.00 UNDER CURRENT APPROPRIATION FY 2007 OF THE CAPITAL OUTLAY OF THE PNP FROM FABRICATION OF ARM RACK TO PURCHASE OF DIGITAL CAMERA AND MAKING FUNDS AVAILABLE THEREFORE.

SECTION II. ORDAINING CLAUSE. That the total amount of P462,515.58 sourced from the lump continuing appropriation and the current appropriation FY 2007 above-mentioned appropriated to different programs, projects and activities embodied in the Status of Appropriations, Allotments and Obligations Form hereto attached as form part of this ordinance is hereby reprogrammed and made available for expenditures for the purchase of Gasoline, Oil and Lubricants and digital camera.

SECTION II. EFFECTIVITY. That this Ordinance shall take upon approval.
