

- d. Traffic – movement of vehicles or persons.
- e. Pedestrians – persons who travel by foot.

**SECTION III. SCOPE AND COVERAGE:** This Ordinance cover and be imposed in all municipal streets, barangay roads and from hospital area to Calacas of Siayan, Zamboanga del Norte.

**SECTION IV. PROHIBITION:** That all owners of vehicles like trucks, bus, vans, automobiles, multicabs and motorcycles are hereby prohibited to utilize the streets and barangay roads as their garage.

**SECTION V. EXEMPTIONS:** Vehicles of all types are exempted if its purpose of parking is to load or unload cargoes and passengers.

**SECTION VI. PENALTY CLAUSE:** Any person or group of persons who may violate this Ordinance shall be penalized as follows:

1 <sup>st</sup> Offense	- Fine of P1,000.00 Phil. Currency
2 <sup>nd</sup> Offense	- Fine of P2,000.00 Phil. Currency
3 <sup>rd</sup> Offense and succeeding offenses	- Fine of not less than P3,000.00 and/or imprisonment of not less than 3 months or both such fine and imprisonment at the discretion of the Court.

**SECTION VII. SEPARABILITY CLAUSE:** If any part of this Ordinance shall be declared as invalid by competent authority or Court of competent jurisdiction other parts not affected thereby shall remain in effect.

**SECTION VII. EFFECTIVITY:** This Ordinance shall take effect immediately after its approval and required publication.

**"MUNICIPAL ORDINANCE NO. 13-11  
Series of 2013**

**AN ORDINANCE CHANGING THE DATE OF THE ANNUAL ARAW NG SIAYAN CELEBRATION FROM JANUARY 27 TO JUNE 17 WHICH IS THE DATE OF CREATION OF THE MUNICIPALITY.**

**SPONSORED BY: HON. FELIZARDO I. GAYAPA, SR.**

**WHEREAS**, the yearly holding of the Araw ng Siayan every January 27 has no relevance nor bearing and importance to its true date of creation as a municipality or town, hence there is a great need to change it.

**BE IT ORDAINED** by the Sangguniang Bayan in Session Assembled that:

**SECTION I. TITLE:** This Ordinance shall be known and referred to as **"CHANGING THE DATE OF THE ARAW NG SIAYAN CELEBRATION FROM JANUARY 27 TO JUNE 17"**.

**SECTION II. DEFINITION OF TERMS:** As used in this Ordinance, the following words and phrases shall mean and be construed as indicated:

- a. Barrio – the old name of a barangay
- b. Relevance – bearing upon the matter at hand
- c. Legal Basis – permitted by law, lawful reference
- d. Culmination – final, consolidated activity

**SECTION III. LEGAL BASIS/REFERENCE:** Per R.A. 4989 *"An Act Creating the Municipality of Siayan in the Province of Zamboanga del Norte"* which was enacted by the Senate and the House of Representatives of the Philippines in Congress assembled and finally passed by the same on May 18, 1967, and later signed and approved by then President Ferdinand E. Marcos on June 17, 1967.

**SECTION IV. SCOPE AND COVERAGE:** The June 17 Annual Araw ng Siayan Celebration shall include the Sixteen (16) original barrios now barangays which were together created that compose the whole Municipality of Siayan, however the main center of the celebration will be in the Poblacion.

**SECTION V. ACTIVITIES:** The usual activities held during the past years celebration shall be conducted the same with more focus and advocacy not only on the aspect of enjoyment of the people but also for economic, social, cultural, moral and educational development. The celebration shall start on June 1 and the culmination program on the 17<sup>th</sup> of the same month.

The culture of the Subanen which are the greater majority of the people living in this municipality shall also be promoted for its recognition and preservation during the celebration.

**SECTION VI. SEPARABILITY CLAUSE:** If any part of this Ordinance shall be declared as invalid by any court of competent authority, other parts thereof not affected shall remain in force and effect.

**SECTION VII. EFFECTIVITY:** This Ordinance shall take effect upon approval and publication required by law has been satisfied.

**"MUNICIPAL ORDINANCE NO. 13-12  
Series of 2013**

**AN ORDINANCE DESIGNATING PORTION OF THE TOURISM PLAZA IN FRONT OF THE MUNICIPAL HALL AS PARKING AREA.**

**SPONSORED BY: HON. RAUL P. DOMINISE**

**BE IT ORDAINED** by the Honorable Sangguniang Bayan of Siayan, Zamboanga del Norte in session assembled:

**SECTION I. TITLE:** This enactment shall be known as **"DESIGNATING THE PARKING AREA OF ALL VEHICLES IN FRONT OF THE MUNICIPAL HALL"**.

**SECTION II. SCOPE AND COVERAGE:** This Ordinance shall apply to all employees, visitors and other individuals that have vehicles for parking purposes,

**SECTION III. DEFINITION OF TERMS:** As used in this Ordinance, the following terms or phrases shall have the following meaning:

- a. Employees – refers to the officers and employees of the Local Government Unit of Siayan, ZN.
- b. Visitors – any person or group of persons had the purpose at the Local Government Unit of Siayan, ZN.
- c. Vehicles – any kind of contrivance, on wheels or runners, used to carry people or goods from one place over land.
- d. Parking – leaving a vehicle temporarily in a space set aside for the purpose.
- e. Area – refers to the portion of the tourism plaza used for parking.

**SECTION IV. DECLARATION OF POLICY:** It is the policy of the Local Government Unit of Siayan to have convenience and safety to all the people inside the municipal complex.

**SECTION V. PROHIBITION ACT:** No person or group of persons shall be allowed to park their vehicles outside the designated parking area.



**SECTION VII. EFFECTIVITY:** This Ordinance shall take effect immediately upon approval.


