"MUNICIPAL ORDINANCE NO. 12-01
Series of 2012

PREFATORY STATEMENT

The Municipal Revenue Code of this municipality was formulated under Ordinance No. 00-002, series of 2000, and in conformance with the provision of Republic Act 7160 known as the Local Government Code of 1991, Chapter 5, Section 191, adjustment of taxes and other imposition of fees and charges shall be done once in every five (5) years hence this enactment.

BE IT ORDAINED, by the Sangguniang Bayan of Siayan, Zamboanga del Norte in session assembled:

CHAPTER 1 – GENERAL PROVISION

ARTICLE A. TITLE AND SCOPE

SECTION 1. TITLE: This Ordinance shall be known as the "Municipal Revenue Code" of the municipality of Siayan, Zamboanga del Norte, Philippines.

SECTION 2. SCOPE: This code shall govern the levy, assessment, collection of taxes, and other imposition fees and charges within the jurisdiction of the municipality of Siayan, Zamboanga del Norte.


ARTICLE B. DEFINITION AND RULES OF CONSTRUCTION

SECTION 213. EFFECTIVITY CLAUSE: This Code shall take effect Sixty days (60) after the approval of the Honorable Sangguniang Panlalawigan of Zamboanga del Norte and the publication of copies in official news papers.


