**"APPROPRIATION ORDINANCE NO. 12-02
Series of 2012**

AN ORDINANCE APPROPRIATING THE SUM OF TWO MILLION FIVE HUNDRED THOUSAND PESOS (PHP 2,500,000.00) FOR THE COMMUNITY FUND FOR AGRICULTURAL DEVELOPMENT (CFAD) PROJECTS ROUND II IN THE MUNICIPALITY OF SIAYAN, ZAMBOANGA DEL NORTE.

BE IT ORDAINED by the Sangguniang Bayan in session assembled:

SECTION I. TITLE. This Ordinance shall be known as Appropriation Ordinance No. 12-02, Series of 2012.

SECTION II. That the sum of TWO MILLION FIVE HUNDRED THOUSAND PESOS (PHP 2,500,000.00) which the total amount is taken from the following sources:

2.1 – LP – MRDP	PhP 1,500,000.00
2.2 – GDP – DA	500,000.00
2.3 – MLGU – Siayan	500,000.00

- Allocated under the 20% Development Fund Appropriation under Ordinance No. 11-18, Series of 2011, dated December 20, 2011.

is hereby appropriated to be made available for the implementation of CFAD Projects under Mindanao Rural Development Project (MRDP) – Adaptable Loan 2 (APL-2) Round II of the Department of Agriculture (DA) in the municipality of Siayan, Zamboanga del Norte.

SECTION III. The Municipal Budget Officer (MBO) of Siayan, Zamboanga del Norte, shall prepare the corresponding statement covering the itemized outlay which shall authorize the Municipal Treasurer to disburse funds relative thereto.

SECTION IV. EFFECTIVITY. That this Appropriation Ordinance shall take effect immediately.
