"APPROPRIATION ORDINANCE NO. 12-04 Series of 2012

PREFATORY STATEMENT

The Municipal Treasurer and Municipal Accountant had certified the availability of funds amounting to ELEVEN MILLION SIX HUNDRED FORTY SEVEN THOUSAND TWO HUNDRED EIGHTY EIGHT PESOS AND FORTY ONE CENTAVOS (PHP 11,647,288.41) sourced from retained earnings FY 2011 which is free of any encumbrances and subject for budgeting to cater the various expenditures of the local government unit of this municipality.

The Municipal Treasurer and Municipal Accountant had certified the availability of funds amounting to ELEVEN MILLION SIX HUNDRED FORTY SEVEN THOUSAND TWO HUNDRED EIGHTY EIGHT PESOS AND FORTY ONE CENTAVOS (PHP 11,647,288.41) sourced from retained earnings FY 2011 which is free of any encumbrances and subject for budgeting to cater the various expenditures of the local government unit of this municipality.

BE IT ORDAINED by the Sangguniang Bayan in session assembled:

SECTION I. TITLE. This shall be known as "AN APPROPRIATION ORDINANCE MAKING AVAILABLE THE AMOUNT OF ELEVEN MILLION SIX HUNDRED FORTY SEVEN THOUSAND TWO HUNDRED EIGHTY EIGHT PESOS AND FORTY ONE CENTAVOS (PHP 11,647,288.41) REPRESENTS RETAINED EARNINGS FY 2011 EMBODIED IN SUPPLEMENTAL BUDGET NO. 1 FY 2012 FOR VARIOUS EXPENDITURES OF THE LOCAL GOVERNMENT UNIT OF SIAYAN, ZAMBOANGA DEL NORTE".

SECTION II. ORDAINING CLAUSE. That the amount of ELEVEN MILLION SIX HUNDRED FORTY SEVEN THOUSAND TWO HUNDRED EIGHTY EIGHT PESOS AND FORTY ONE CENTAVOS (PHP 11,647,288.41) is hereby made available for various expenditures of the local government unit. Statement of Supplemental Appropriation (LBP Form N0.10) is hereto attached form part of this ordinance.

SECTION III. EFFECTIVITY. That this ordinance shall take effect upon approval.
