"MUNICIPAL ORDINANCE NO. 12-05  
Series of 2012

PREFATORY STATEMENT

The responsibility of the Philippine National Police (PNP) being the law enforcers is to detect crimes, apprehend the perpetrators, and provide evidence that will convince the courts of law that the perpetrators are guilty beyond reasonable doubt.

To accomplish these aims, a variety of methods are used, including reconstructing the crime, collecting physical clues and interrogating suspects and witnesses, but most probably physical clues and other kind of evidence be collected in the crime scene.

However, the law enforcer might be ineffective in gathering evidences in the crime scene due to the presence of kibitzers locally known as "usiseros". The presence of these people (Kibitzers) in the crime scene may cause contamination of something that gives a sign or proof of the existence or truth.

The main objective of this ordinance is to prohibit, and refrain any person or group of persons who insist, interfere and trespass beyond the established police line and/or crime scene tape being used by the Siayan PNP to cordon off the crime scene.

BE IT ORDAINED by the Sangguniang Bayan in session assembled:

SECTION I. TITLE. This shall be known as an "ORDINANCE PENALIZING "USISERO'S OR KIBITZERS" WHO INSIST ON BREACHING A POLICE LINE AND/OR CRIME SCENE TAPE SET UP BY THE SIAYAN PNP WITHIN THE PREMISES OF CRIME SCENE IN THE MUNICIPALITY OF SIAYAN, ZN.

SECTION II. DEFINITION OF TERMS:

- a. Kibitzers/Usiseros – one who looks on and offers unwanted advice or comment; one who offers opinion.
- b. Perpetrators – a person who perpetrates or commits an illegal, criminal, or evil act.
- c. Crime Scene Tape – a bright yellow official crime scene barrier tape use for blocking off danger areas.
- d. Crime Scene – is the location where the crimes took place.
- e. Enforcers – a person especially a public official who enforces laws.
- f. Police Line – a line, often marked with yellow tape, demarcating a crime or accident scene and which bystanders are not supposed to cross.
- g. Breaching – break or fail to observe.

**SECTION III. SET UP OF POLICE LINE/CRIME SCENE TAPE:** In the course of action conducted by the Siayan PNP in gathering physical clues and whatever substantial evidences if ever violence/criminalities occurred and fire accident, police line (crime scene tape) or barricade tape shall be established to cordon off an area to serve as a signage warning people of a crime scene.

**SECTION IV. RESTRICTION/PROHIBITION:** Any person or group of persons who is civilian in nature is strictly prohibited to interfere, trespass and insist in breaching beyond the established police line and/or crime scene tape being used by the Siayan PNP to cordon off the crime scene and fire accident.

**SECTION V. PENALTY:** Any violation of this ordinance shall be penalized a fine in the amount of P500.00 and an imprisonment of 30 days or both fine and imprisonment upon the discretion of the Honorable court.

**SECTION VI. EFFECTIVITY:** This ordinance shall take effect upon approval of the Honorable Sangguniang Panlalawigan of Zamboanga del Norte and publication in a newspaper of general circulation in the province.
