"ORDINANCE NO. 00-12 Series 2000

MUNICIPAL ORDINANCE REQUIRING ANY PERSON OR GROUP OF PERSONS TO SECURE/CMPLY PERTINENT PAPERS PRIOR TO TRANSPORT BAMBOO TREE, GEMELINA AND MAHOGANY LUMBERS FROM SIAYAN, ZAMBOANGA DEL NORTE.

BE IT ORDAINED by the Honorable Sangguniang Bayan in session assembled:

SECTION I. TITLE: This Ordinance shall be known "An Ordinance requiring any person or group of persons to secure/comply pertinent papers prior to transport bamboo tree, mahogany and gemelina lumbers from Siayan, Zamboanga del Norte".

SECTION II. ORDAINING CLAUSE: That any person or group of persons who will transport bamboo trees, gemelina and mahogany lumbers obtained from the municipality of Siayan to other places for whatever purposes shall secure the following pertinent papers:

- Certification from the Barangay Captain on the real owner of the land where the bamboo tree, gemelina and mahogany were cut reflecting therein the Title No., Lot No., and Declaration No., etc.
- Certification of the Municipal Treasurer that the land owner had paid the real property tax on the land where the bamboo trees, gemelina and mahogany lumbers obtained.
 Certification of the Municipal Treasurer is pre-requisite to
- Mayor's permit to transport.

SECTION III. PENALTY CLAUSE: That any person or group of persons who violate the provisions of this ordinance shall be fined in the amount of FIVE HUNDRED PESOS (P500.00) BUT NOT MORE THAN ONE THOUSAND PESOS (P1,000.00) and imprisonment of 15 days but not more than 30 days or both fines and imprisonment upon the discretion of the honorable court.

SECTION IV. EFFECTIVITY CLAUSE: That this Ordinance shall take effect Sixty days (60) after approval and publication, posting of copies at conspicuous places.
