**"MUNICIPAL ORDINANCE NO. 13-04
Series of 2013**

PREPATORY STATEMENT

The Local Government Unit of Siayan, Zamboanga del Norte had newly acquired one (1) unit back hoe.

The operation and/or services of said heavy equipment shall be compensated to generate income and for the maintenance of its tear and wear.

This ordinance is form part of the Municipal Revenue Code.

BE IT ORDAINED by the Sangguniang Bayan in session assembled:

SECTION I. TITLE: This shall be known as "AN ORDINANCE IMPOSING FEES, RENTALS AND OTHER CHARGES OF THE NEWLY ACQUIRED BACK HOE OF THE LOCAL GOVERNMENT UNIT OF SIAYAN, ZAMBOANGA DEL NORTE."

SECTION II. FEES AND CHARGES: Fees and charges is hereby imposed in the following schedules:

| 1. For government entities | - P12,000.00/day (8 working hours) with Operator and Assistant Operator excluding fuel and lubricants.

P1,500.00/hour additional pay in excess of 8 hours. |
| 2. For Private Contractors/any person | - P17,000.00/day (8 working hours) with Operator and Assistant Operator excluding fuel and lubricants.

- P2,125.00/hour additional pay in excess of 8 hours. |


SECTION III. MISCELLANEOUS PROVISIONS: The eight (8) working hours shall commence from the equipment started to work.


SECTION IV. ADMINISTRATIVE PROVISION: That the RENTEE shall file Equipment Rental and Request Order (ERRO) in the Office of the Municipal Engineering and pay the corresponding fees and/or charges herein imposed in the Office of the Municipal Treasurer.

SECTION V. EFFECTIVITY CLAUSE: That this Ordinance shall take effect upon approval.
