AN ORDINANCE CONTROLLING THE SPEED OF ALL VEHICLES PASSING THE STREETS OF POBLACION, SIAYAN AND NEAR THE SCHOOLS, CHURCHES, PUBLIC MARKETS OF THE MUNICIPALITY OF SIAYAN, ZAMBOANGA DEL NORTE.

WHEREAS, the numbers of vehicles passing/travelling in the streets of Poblacion of Siayan and near the schools, churches, public markets of the municipality of Siayan had increased considerably;

WHEREAS, it had been observed that these vehicles including motor single motorcycles travel very fast unmindful of the safety of people, school children walking by, thus vehicular accidents happened several times;

WHEREFORE, premise considered and on motion of Hon. Felizardo I. Gayapa, Sr., duly seconded by Hon. Primitivo D. Castillo and Hon. Raul P. Dominise,

BE IT ORDAINED BY THE SANGGUNIANG BAYAN OF SIAYAN, ZAMBOANGA DEL NORTE THAT:

SECTION I. TITLE: This Ordinance shall be known and cited as 'AN ORDINANCE CONTROLLING THE SPEED OF ALL VEHICLES PASSING THE STREETS OF POBLACION, SIAYAN AND NEAR THE SCHOOLS, CHURCHES AND PUBLIC MARKETS OF THE MUNICIPALITY OF SIAYAN, ZAMBOANGA DEL NORTE.

SECTION II. SCOPE AND COVERAGE: This Ordinance shall apply to all types of vehicles passing the streets of Poblacion, Siayan and while passing/travelling near the schools, churches and public markets of the municipality of Siayan, Zamboanga del Norte.

SECTION III. DEFINITION OF TERMS. As used in this Ordinance, the following words and phrases shall mean and be construed as indicated:

- Vehicles – machines fueled by gasoline crude used for transport.
- Speed – the rated vehicles travelling/number of kilometers per hour.
- Vehicular accidents – road accidents involving vehicles.
- KPH – Kilometer Per Hour.

SECTION IV. PROHIBITION: No vehicles shall be allowed to travel more than thirty (30) kilometers per hour while passing in all streets of Poblacion, Siayan and near the schools, churches and public markets in the municipality.

SECTION V. PENAL CLAUSE: Any person or group of persons who violate this Ordinance shall be penalized as follows:

| 1 st Offense | - fine of P300.00 |
| 2 nd Offense | - fine of P500.00 |
| 3 rd and succeeding offenses | shall be fine of P1,000.00 but not more than P2,000.00 or imprisonment of not less than one (1) month but not more than three (3) months or both such fine and imprisonment at the discretion of the Court. |


SECTION VI. REPEALING CLAUSE: Any Ordinance or Provision thereof is contrary to/or inconsistent with the Ordinance is hereby modified or repealed accordingly.


SECTION VII. SEPARABILITY CLAUSE: Any provision of this Ordinance which shall be declared by any competent authority as invalid, other parts thereof which are not affected shall remain operational.

SECTION VIII. EFFECTIVITY: This Ordinance shall take effect immediately upon approval and compliance with the required publication and/or posting.




