"MUNICIPAL ORDINANCE NO. 13-09
Series of 2013

AN ORDINANCE PROHIBITING THE RESIDENTS AND BUSINESS ESTABLISHMENTS IN THE MUNICIPALITY OF SIAYAN, ZAMBOANGA DEL NORTE IN UTILIZING THE MUNICIPAL STREETS AS WORK PLACE AND DISPLAY AREA.

WHEREAS, the Municipal Streets of Siayan are narrow enough due to the hilly terrain and limited space, hence it is appropriate and proper that it must be free from any obstruction for the commuters, pedestrian and vehicles to safely pass.

BE IT ORDAINED by the Sangguniang Bayan in Session Assembled:

SECTION I. TITLE: This Ordinance shall be known and referred as "**PROHIBITING THE RESIDENTS AND BUSINESS ESTABLISHMENTS IN SIAYAN IN UTILIZING THE STREETS AS WORKPLACE AND DISPLAY AREA**".

SECTION II. DEFINITION OF TERMS: For purpose of this Ordinance, these terms shall have the following meaning:

- a. Commuters – regular travelers between places, especially between home and work
- b. Pedestrian – persons passing the streets, passersby
- c. Workplace – area for working
- d. Terrain – the condition of the land

SECTION III. SCOPE AND COVERAGE: This Ordinance shall cover all Streets in the Poblacion, Siayan, Zamboanga del Norte.

SECTION IV. PROHIBITION: That all residents and business establishments in the municipality of Siayan are hereby prohibited to utilize the streets as place for working and display area for their products, materials and other goods.

SECTION V. PENALTIES: Any person who violates this Ordinance shall be penalized with a fine of not less than P1,000.00 but not more than P2,000.00 or imprisonment of not less than one (1) month but not more than three (3) months or both such fine and imprisonment at the discretion of the court.

SECTION VI. SEPARABILITY CLAUSE: If any part of this Ordinance shall be declared as unconstitutional or invalid by any court of competent jurisdiction, other parts not affected shall thereby remain in effect.

SECTION VII. EFFECTIVITY: This Ordinance shall take effect upon its approval and required publication.


