**"MUNICIPAL ORDINANCE NO. 13-13  
Series of 2013**

AN ORDINANCE REQUIRING ALL EMPLOYEES OF THE LOCAL GOVERNMENT UNIT AND NATIONAL AGENCIES ASSIGNED INCLUDING ALL BARANGAY OFFICIALS AND EMPLOYEES AT THE DIFFERENT BARANGAYS IN THE MUNICIPALITY OF SIAYAN, ZAMBOANGA DEL NORTE TO WEAR SUBANEN ATTIRE IN EVERY FIRST MONDAY OF THE MONTH.

WHEREAS, Republic Act No. 8571, otherwise known as the Indigenous Peoples Rights Act (IPRA) of 1997 provides important role and involvement of the cultural communities among all other sectors in the operation of local governance;

WHEREAS, on the other hand, the Sangguniang Bayan of Siayan passed an Ordinance No. 96-016, Series of 1996 giving importance to the subanen tribe by declaring the first Wednesday of October every year as "Subanen Tribal Day" a very significant celebration to commemorate its culture and tradition;

WHEREAS, 75% populace in this municipality is the subanen, however it is seldom to see the real physical image of this people which was identified through their clothing or attire and this might be loss nowadays;

WHEREAS, in order to preserve the real image of a subanen and to be physically exist as a landmark of this municipality being a subanen community thus this enactment.

BE IT ORDAINED by the Sangguniang Bayan of Siayan, Zamboanga del Norte, that:

SECTION I. TITLE: This shall be known and referred to as "AN ORDINANCE REQUIRING ALL EMPLOYEES OF THE LOCAL GOVERNMENT UNIT AND NATIONAL AGENCIES ASSIGNED INCLUDING ALL BARANGAY OFFICIALS AND EMPLOYEES AT THE DIFFERENT BARANGAYS IN THE MUNICIPALITY OF SIAYAN, ZAMBOANGA DEL NORTE TO WEAR SUBANEN ATTIRE IN EVERY FIRST MONDAY OF THE MONTH.

SECTION II. SCOPE AND COVERAGE: This Ordinance shall cover all barangay, municipal and national officials and employees stationed in the municipality including the Teaching Staff and personnel of the Department of Education (DepEd), Siayan District, Cooperatives, banking institutions and among others;

SECTION III. DEFINITION OF TERMS: As used in this Ordinance, the following terms or phrases shall have the following meaning:

- a. Attire – refers to the clothing or dress wear by any person.
- b. Barangay Officials and employees – refers to the Barangay Captains, Sangguniang Barangay members, Barangay Treasurer and Secretary and other personnel appointed by the Barangay Captain
- c. Employees – refers to the regular and casual plantilla employees of the LGU of Siayan, ZN.
- d. National Employees – refers to the personnel of national agencies assigned in this municipality like the PNP, DILG, DAR/MARO, DEPED.


SECTION IV. ORDAINING CLAUSE: That every first Monday of the month is hereby declared that all national/local and barangay officials and employees to wear subanen attire.


SECTION V. SEPARABILITY CLAUSE: If any part of this ordinance may be declared unconstitutional or contrary to national statutes or ordinance passed by the Sangguniang Panlalawigan, other parts or provisions thereof not affected shall remained valid and in effects.

SECTION VI. EFFECTIVITY CLAUSE: That this Ordinance shall take effect thirty (30) days after approval and publication of copies by posting in conspicuous places, publishing in newspapers of general circulation and furnishing to all concerned.
