"MUNICIPAL ORDINANCE NO. 13-14  
Series of 2013

PREFATORY STATEMENT

It is the prescribed power of the local government unit to exercise its power to create its own sources of revenue and levy taxes, fees and charges provided under Section 129, of RA 7160 known as the Local Government Code of 1991.

In pursuant to the provisions of Section 129, RA 7160, the Sangguniang Bayan has formulated its Municipal Revenue Code as the basis in the imposition of taxes, fees and charges of all kinds of business, investments, and among others.

Just recently, the Municipal Treasurer made representation before this august body that the Municipal Revenue Code has no Transportation Permit fee of large cattle and other domestic animals, hence this ordinance.

BE IT ORDAINED by the Sangguniang Bayan in session assembled:

SECTION I. TITLE. This shall be known as "MUNICIPAL REVENUE ORDINANCE IMPOSING TRANSPORTAL PERMIT FEE OF LARGE CATTLE AND OTHER DOMESTIC ANIMALS IN THE MUNICIPALITY OF SIAYAN, ZAMBOANGA DEL NORTE.

SECTION II. IMPOSITION OF FEES: Any private person or group of persons, buyers and the like who will transport any kind of large cattle and other domestic animals from the municipality of Siayan to other places shall be collected a transportation permit fee herein impose in the following schedule:

LARGE CATTLE	Fees/Head
a. Carabao	- 100.00
b. Cow	- 100.00
c. Horse	- 100.00
OTHER DOMESTIC ANIMALS	
a. Hog	- 30.00
b. Goat	- 30.00
c. Sheep	- 30.00
d. Fowl	- 5.00


SECTION IV. ADMINISTRATIVE PROVISION: Any private person or group of person, buyers and the like who will transport any kind of large cattle and other domestic animals from the municipality of Siayan to other places shall secure a TRANSPORTATION PERMIT from the Office of the Municipal Mayor upon payment of the corresponding fees and charges in the Office of the Municipal Treasurer.

SECTION V. PENALTY CLAUSE: Any person or group of persons who violates this Ordinance shall be penalized of a fines of not more than P1,000.00 or an imprisonment of 15 days but not more than 30 days or both fines and imprisonment at the discretion of the Honorable Court.


