**"MUNICIPAL ORDINANCE NO. 13-15  
Series of 2013**

**PREFATORY STATEMENT**

As part of the Legislative Tracking and Analysis, the Sangguniang Bayan had scrutinized all acted ordinances from the existence of this municipality up to this present to determine its effectiveness or non-effectiveness that no longer necessary and needs amendments and/or to be repealed.

As per records, Municipal Ordinance No. 06-06, series of 2006 was found inconsistent with other Ordinance which is contradicting in its implementation and necessary to be amended, stated hereunder:

Municipal Ordinance No. 06-06, series of 2006 is known as **"AN ORDINANCE ESTABLISHING THE SYSTEM OF GARBAGE COLLECTION AND PROPER WASTE DISPOSAL, HEALTH PROTECTION AND SANITATION AND IMPOSING FEES THEREFORE AND FOR OTHER RELATED PURPOSES IN THE MUNICIPALITY OF SIAYAN, ZAMBOANGA DEL NORTE."**

Municipal Ordinance No. 06-06 above-stated is imposing Garbage collection fee reflected under Section 1 to Section 2, Article X of the different business establishment which were already covered under the Municipal Revenue Code hence necessary to be amended in this effect to remove the imposition of fees.

BE IT ORDAINED by the Sangguniang Bayan in session assembled:

SECTION I. TITLE: This shall be known as **"AMENDMENTS TO THE MUNICIPAL ORDINANCE NO. 06-06, SERIES OF 2006 ESTABLISHING THE SYSTEM OF GARBAGE COLLECTION AND PROPER WASTE DISPOSAL, HEALTH PROTECTION AND SANITATION AND IMPOSING FEES THEREFORE AND FOR OTHER RELATED PURPOSES IN THE MUNICIPALITY OF SIAYAN, ZAMBOANGA DEL NORTE."**


SECTION II. AMENDMENTS: The garbage collection fees provided under Article X, Section 1 to Section 2 of the Municipal Ordinance No. 06-06, Series of 2006 is hereby revoke and no longer be the basis in the collection of garbage fee of the Municipal Treasurers Office.

SECTION III. ADMINISTRATIVE PROVISION: The collection of garbage fees of the different business establishments shall be based on the Municipal Revenue Code under Municipal Ordinance No. 12-01, Series of 2012.

SECTION IV. EFFECTIVITY. This ordinance shall take effect upon approval
