"MUNICIPAL ORDINANCE NO. 13-16 Series of 2013

WHEREAS, the 1st Wednesday in the month of October every year was declared as "Araw ngSubanen" by virtue of Municipal Ordinance No. 96-016, Series of 1996;

WHEREAS, the "Araw ng Subanen" was legally declared in honor to the cultural communities particularly the subanen tribe which is the majority populace in this municipality;

WHEREAS, it was observed that during the culmination of the Araw ng Subanen on the day above-mentioned, the participation of the employees of the different government offices, as well as the personnel and students of the Department of Education (DepEd) Elementary and Secondary level, are very indispensable, however, they cannot participate in view that it is an office hour;

WHEREAS, in order to make these people may involve on the celebration it is very necessary to declare legally the 1st Wednesday of October as non-working holiday, hence this enactment;

BE IT ORDAINED by the Sangguniang Bayan in session assembled:

SECTION I. TITLE: This shall be known as "AN ORDINANCE DECLARING THE 1ST WEDNESDAY OF OCTOBER EVERY YEAR AS NON-WORKING HOLIDAY IN THE MUNICIPALITY OF SIAYAN, ZAMBOANGA DEL NORTE IN CELEBRATION OF THE "ARAW NG SUBANEN".

SECTION II. ORDAINING CLAUSE: The 1st Wednesday in the month of October every year is hereby declared as a Non-working holiday to all government offices, Department of Education (DepEd)-Siayan District, government controlled and private entities, banking institutions, cooperatives, Non-Government Organizations (NGO), PO's and the like existing this municipality.

SECTION III. EFFECTIVITY: This Ordinance shall take effect upon approval of the Hon. SangguniangPanlalawigan in the province of Zamboanga del Norte and publication in official gazette.
