ORDINANCE NO. 00-013 Series of 2000

AN ORDINANCE MAKING AVAILABLE THE AMOUNT OF TWO HUNDRED SEVENTY TWO THOUSAND NINE HUNDRED SIXTY SIX PESOS AND THIRTY EIGHT CENTAVOS (P272,966.38) FOR FUNDING ALLOCATION OF VARIOUS DEVELOPMENT PROJECTS PRIORITY IMPORTANCE OF THE LOCAL GOVERNMENT UNIT OF SIAYAN, ZAMBOANGA DEL NORTE, CY 2001.

PREFATORY STATEMENT

The Local Government Unit of Siayan, Zamboanga del Norte is recipient of a financial assistance from the DOLE for fresh fish culture and cut flower farming. The present scheme of project implementation is a cost sharing between the national government and local government unit. To comply with the local counterpart, savings from previous years program appropriations was reprogrammed/realigned by the Municipal Development Council which conform with the provisions of Section 336 of R.A. 7160, yet supplemented with this ordinance authority for expenditures.

BE IT ORDAINED, by the Honorable Sangguniang Bayan in session assembled:

SECTION L TITLE: Ar, ordinance making available the amount of P272,966.38 reprogrammed amount constituting the savings of the previous years 20% continuing appropriations and other unexpended balances.

SECTION II. PURPOSE: That the said reprogrammed amount is intended to purchase lots for the establishment of inland fresh water fish ponds for fresh fish culture and to procure ornamental plants for cut flower farming which are more priority importance.

SECTION III. ORDAINING CLAUSE: That the amount of P272,966.38 is hereby made available for expenditures of the said projects.

SECTION IV. EFFECTIVITY: That this ordinance shall take effect upon its approval.
