"MUNICIPAL ORDINANCE NO. 07-13
Series of 2007

PREFATORY STATEMENT

The Local Government Unit of this municipality has embarked on a program of Rubber Production and is determined to pursue for its implementation this year 2007 as its sure means of attaining socio-economic and environmental development that contribute to the realization of the goals and objectives of the Philippine Agenda 21 and the Millennium Development Goals (MDG) of the national government.

The amount of P2M per annum has been allocated for its realization and besides of the flagship program of the present administration related to rubber production the local farmers and land-owners encourage to plant rubber trees at their own risk incurring expenses due to the maximum projected income earn from the marketable value of rubber produce.

This ordinance is a preventive and/or safety measure to all rubber planters against manmade damages, astray animals and whatsoever damages which is intentionally and/or unintentionally done.

BE IT ORDAINED by the Honorable Sangguniang Bayan in session assembled:

SECTION I. TITLE. This shall be known as "AN ORDINANCE PENALIZING ANY PERSON OR GROUP OF PERSONS, OWNERS, CARETAKER OF LARGE CATTLE AND OTHER DOMESTIC FARM ANIMALS WHO CAUSED THE DAMAGES, DESTROY OF PLANTED RUBBER TREES WITHIN THE MUNICIPALITY OF SIAYAN, ZAMBOANGA DEL NORTE".

SECTION II. ORDAINING CLAUSE. That any person group of persons, owners/caretakers of large cattle and other domestic farm animals who caused the damages/ destroy of planted rubber trees within the municipality of Siayan shall be penalized in the following instances:


- a) The amount of P150.00 pesos per hill shall be paid by the person or group of persons who intentionally cause the damage through cutting, uprooting, burning and by any means.
- b) The same the amount of P150.00 per hill shall be paid by the owner and/or caretaker of large cattle like Carabao, Cow, Horse and other domestic farm animals like pig, goat, dog and among others that cause the damage.
- c) The large cattle and other domestic farm animals that caught in the act shall be apprehended and be deposited to the barangay government concerned where the rubber plantation located and be released after the owner/caretaker had paid the corresponding charges and impounding fee of the barangay.
- d) Besides of the penalty in the amount of P150.00 pesos per hill, any person or group of persons, owner/caretaker of large cattle and domestic farm animals who cause the damage of rubber planted trees shall provide the seedlings for its replanting.

- e) That the owner/caretaker who remain silent and never even attempt to pay and or redeemed his/her apprehended large cattle or domestic animals shall be summoned through the Office of the Barangay Captain or upon the discretion of the owner of the damage planted rubber trees through the PNP in the municipality of Siayan for settlement.
- f) The same case if the owner/caretaker refused to settle the damages, therefore it signifies authority to sell his/her apprehended large cattle/domestic animals through public auction, less the payable charges and impounding fees of the barangay government concerned and the excess of the sales shall be returned to the owner/caretaker of the large cattle/domestic animals, and/or such disputes could not be given remedial to be settled thus the owner of the damages rubber planted trees has the option to refer to the Honorable court for final decision.


SECTION III. EFFECTIVITY. That this Ordinance shall take effect after 30 days and posting of copies at conspicuous places and publish in official gazette.
