"MUNICIPAL ORDINANCE NO. 11-13 Series of 2011

PREFATORY STATEMENT

WHEREAS, it has been a long time that a portion of land owned by Late Rafaela Lanticse Vda de Flores, under Lot No. 2538-D-4P-1, measuring 307.20 Square meters, located at Upper Riverside, Poblacion, Siayan, Zamboanga del Norte was utilized as Municipal Road, yet, no pertinent documents particularly Deed of Donatlon, Road Right of Way and the like;

WHEREAS, the legal heirs of late Refaela Lanticse vda de Flores established a roadblock of the above-described portion of land preventing any government dump trucks and other vehicles to pass resulting the delay in the delivery of basic services by the LGU at Barangay Moyo, likewise commercial activities of all businessmen in this area also experienced consequences in transporting their goods;

WHEREAS, for public welfare, this august body authorized the Hon. Municipal Mayor Flora L. Villarosa to exercise the power of eminent domain over the afore-cited portion of land under Resolution No. 191, Series of 2011;

WHEREAS, unfortunately, based on Republic Act 7160, known as the Local Government Code of 1991 clearly mentioned that authorizing the Local Chief Executive to exercise the expropriation proceedings over a private land for public purposes shall be in form of ordinance;

WHEREAS, in compliance with the provision of the law, this Ordinance is hereby acted in lieu of Resolution No. 191, Series of 2011;

ORDAINED, by the Sangguniang Bayan in session assembled:

SECTION I. TITLE: This shall be known as "AN ORDINANCE GRANTING AUTHORITY TO THE HONORABLE MUNICIPAL MAYOR FLORA L. VILLAROSA TO EXERCISE THE POWER OF EMINENT DOMAIN OVER A PORTION OF PRIVATE LAND UNDER LOT NO. 2538-D-4P-1 OWNED BY LATE RAFAELA LANTICSE LOCATED AT UPPER RIVERSIDE, POBLACION, SIAYAN, ZAMBOANGA DEL NORTE APPROXIMATELY 307-2 SQUARE METERS FOR ROAD PURPOSES.
