**"MUNICIPAL ORDINANCE NO. 14-01
Series of 2014**

**AN ORDINANCE PROHIBITING THE OWNERS OF MOTOR VEHICLES IN THE
MUNICIPALITY OF SIAYAN, ZAMBOANGA DEL NORTE IN UTILIZING THE MUNICIPAL
STREETS AS VEHICLE GARAGE.**

WHEREAS, it is usual practice of some vehicle owners to park their trucks, bus, vans, automobiles, multicabs and motorcycles along the municipal streets of Siayan, Zamboanga del Norte, making the streets as garage;

WHEREAS, it is observed further that these parked vehicles caused traffic problems to the pedestrians and passersby, hence it is imperative that the streets shall be made safe and free of any obstruction;

BE IT ORDAINED by the Honorable Sangguniang of Siayan, Zamboanga del Norte in Session assembled, that:

SECTION I. TITLE: That this Ordinance shall be known and referred hereto as **"PROHIBITING THE MOTOR VEHICLE OWNERS IN UTILIZING THE STREETS AS GARAGE"**.

SECTION II. DEFINITION OF TERMS: As used in this Ordinance, the following words and phrases shall mean and construed as indicated:

- a. Garage – for storing or parking area of vehicles.
- b. Motor vehicles – machines fueled by gasoline or crude.
- c. Obstruction – to block, to hinder the passage.
- d. Traffic – movement of vehicles or persons.
- e. Pedestrians – persons who travel by foot.

SECTION III. SCOPE AND COVERAGE: This Ordinance cover and be imposed in all municipal streets, barangay roads and from hospital area to Calacas of Siayan, Zamboanga del Norte.

SECTION IV. PROHIBITION: That all owners of vehicles like trucks, bus, vans, automobiles, multicabs, and motorcycles are hereby prohibited to utilize (he streets and barangay roads as their garage.

SECTION V. EXEMPTIONS: Vehicles of all types are exempted if its purpose of parking is to load or unload cargoes and passengers.

SECTION VI. PENALTY CLAUSE: Any person or group of persons who may violate this Ordinance Shan be penalized as follows:

1st Offense	-	Fine of P1,000.00 Phil. Currency
2nd Offense	-	Fine of P2,000.00 Phil. Currency
3rd Offense and succeeding offenses-		Fine of not less than P 3,000.00 and/or imprisonment of not less than 3 months or both such fine and imprisonment at the discretion of the Court.

SECTION VII. SEPARABILITY CLAUSE: If any part of this Ordinance shall be declared as invalid by competent authority or Court of competent jurisdiction other parts not affected thereby shall remain in effect.


SECTION VIII. EFFECTIVITY: This Ordinance shall take effect immediately after its approval and required publication


