"MUNICIPAL ORDINANCE NO. 14-02 Series of 2014

PREFATORY STATEMENT

WHEREAS, the yearly celebration of the Araw ng Siayan every January 27 has no relevance nor bearing and importance to its true date of creation as a municipality or town, hence there is a great need to change it.

BE IT ORDAINED by the Sangguniang Bayan in session assembled that:

SECTION I. TITLE: This shall be known and referred to as "AN ORDINANCE CHANGING THE DATE OF THE ARAW OF THE MUNICIPALITY OF SIAYAN, ZAMBOANGA DEL NORTE FROM JANUARY 27 TO JUNE 17 EVERY YEAR WHICH IS THE DATE OF ITS CREATION BY VIRTUE OF RA 4989".

SECTION II. DEFINITION OF TERMS: As used in this Ordinance, the following words and phrases shall mean and be construed as indicated:

- a. Barrio the old name of a barangay
- b. Relevance bearing upon the matter at hand
- c. Legal Basis permitted by law, lawful reference
- d. Culmination final, consolidated activity

SECTION III. LEGAL BASIS/REFERENCE: Per R.A. 4989 "An Act Creating the Municipality of Siayan in the Province of Zamboanga del Norte" which was enacted by the Senate and the House of Representatives of the Philippines in Congress assembled and finally passed by the same on May 18, 1967, and later signed and approved by then President Ferdinand E. Marcos on June 17, 1967.

SECTION IV. ORDAINING CLAUSE: The date of Araw ng Siayan, Zamboanga del Norte is hereby change from January 27 to June 17 every year that will start this year 2014.

SECTION V. ACTIVITIES: The local government unit with the participation of all barangay officials of the different barangays in this municipality will celebrate the Araw ng same with more focus and advocacy not only on the aspect of enjoyment of the people but also for economic, social, cultural, moral and educational development. The celebration shall start on June 10 and the culmination program on the 17th day.

The culture of the Subanen which are the greater populace living in this municipality shall also be promoted for its recognition and preservation during the celebration.

SECTION VI. SEPARABILITY CLAUSE: If any part of this Ordinance shall be declared as invalid by any court of competent authority, other parts thereof not affected shall remain in force and effect.

SECTION VII. EFFECTIVITY: This Ordinance shall take effect upon approval and publication required by law has been satisfied.

Begun and held in the City of Manils on Monday, the twenty-third day of January, mineteen hundred and sixty-seven. - - -000- - -

REPUBLIC ONCI NO. 4989

AN ACT CREATING THE MUNICIPALITY OF SIAYAN IN THE PROVINCE OF ZAMBOANGA DEL NORTE.

Be it enacted by the Senate and the House of Representatives of the Philippines in Congress assembled:

SECTION I. Barrics Siayan Proper, Polayo, Moyo, Diongan, Gonayen, Proper, Datagan, Macasing, Seriac, Gunyan, Dinoyan, Pange, Balok, Litolet, Mangilay, Domogok, and Paranglumba, are hereby separated from the Municipality of Sindangan, Province of Zamboanga del Norte, and constituted into a district and independent municipality, to be known as the Municipality of Siayan in the Province of Zamboanga del Norte. The seat of government of the new municipality shall be in the present site of Barrio Siayan Proper.

SEC. 2. The new Municipality of Siayan shall be bounded on the North, from the boundary of Manukan, astraight line originating from Dalongdong to the course of Moyo-Daku Creek, and thence to its mouth meeting Piao River; on the East by the municipalities of Molave and Dumingag, Province of Zamboanga del Sur; on the South from the interior of Gonain, thence to Macasing, thence to upper Nato; and on the West from Upper Nato to Datagan, thence to Polayo and Denoyan thence to the

SEC. 3. The Municipality of Siayan shall acquire corporate existence mouth of Moyo-Daku Creek. upon the election and qualification of the first Mayor, Vice Mayor and councilors in the next general elections for local officials. For election purposes, the Municipal Officials of the mother municipality charged with the election duties in accordance with the Revised Election Code shall have been elected and qualified.

SEC. 4. This Act shall take effect upon its approval.


