PREFATORY STATEMENT

Previously, the Local Government Unit celebrated the Founding Anniversary of the municipality of Siayan in every 26<sup>th</sup> and 27<sup>th</sup> day of January every year by virtue of R.A. 4989. **"An Act Creating the Municipality of Siayan in the Province of Zamboanga del Norte"** and the same dates was declared by the Sangguniang Bayan as Special Holiday under Municipal Ordinance No. 07-01, Series of 2007.

The celebration will be highlighted a one week activities specially different sport competitions, recognitions of past leaders who in one way contributed much in the development of this municipality, awarding of outstanding/model family in every barangay, Search for Pangase Festival Queen, agro-industrial fair, competition of local wine making (Pangase), etc, and on the last day will be culminated of foods and drinks for the visitors prepared by the LGU itself and the households particularly the employees;

However, just recently the legislators noticed that the creation of the municipality of Siayan under RA 4989 was finally passed by the Congress on May 18, 1967, and later signed and approved by then President Ferdinand E. Marcos on June 17, 1967, therefore the celebration of the founding anniversary of Siayan was transferred to June 17 every year under Ordinance No. 14-02, Series of 2014 and was declared OPERATIVE by the Hon. Sangguniang Panlalawigan under Resolution No. 186, dated April 7, 2014.

BE IT ORDAINED by the Sangguniang Bayan in Session assembled:

SECTION I. TITLE: This shall be known as "AN ORDINANCE DECLARING THE 17<sup>TH</sup> DAY OF JUNE EVERY YEAR AS SPECIAL HOLIDAY OF SIAYAN, ZAMBOANGA DEL NORTE".

SECTION II. ORDAINING CLAUSE: That the 17<sup>th</sup> day of June every year is hereby declared as Special Holiday in the municipality of Siayan, Zamboanga del Norte, provided however, all employees, Department Heads of the different offices/agencies national and/or local government units will render services if the necessity/exigency exist.

SECTION IV. EFFECTIVITY: That this Ordinance shall take effect upon approval and posting of copies at conspicuous places and publication in official gazette.





RESOLVED, as it is hereby resolved, to approve the recommendation of the Committee on Laws, Ordinances, Resolutions, Rules and Style per Report No. LORRS-14-05, dated August 25, 2014, that Municipal Ordinance No. 14-06, s. 2014 of the Sanggunian Bayan of Siayan, this province, declaring the 17<sup>th</sup> day of June every year as Special Holiday of Siayan, Zamboanga del Norte, *be declared invalid*, it being violative to the provisions of Section 27 of the Administrative Code of 1987, which provides that "The President may proclaim any local special day for a particular date, group or place".
