**"MUNICIPAL ORDINANCE NO. 14-10
Series of 2014**

PREFATORY STATEMENT

AUTHORED BY HONORABLE FELIZARDO I. GAYAPA, SR.

WHEREAS, the Local Government Unit of this municipality have launched the fruit trees planting project at the both sides along the national road from Sindangan-Siayan boundary in barangay Denuyan up to the Dumingag-Siayan boundary in barangay Soguilon;

WHEREAS, this laudable project will greatly make a wholesome, beautiful environment, provide shade and above all fruits to the people of the Communities and such these fruit trees must be cared and protected;

WHEREAS, tying of all kinds of animals within this perimeters might be destroyed the planted fruit trees, hence this ordinance.

BE IT ORDAINED by the Sangguniang Bayan in session assembled:

SECTION I. TITLE. This Ordinance shall be known as "AN ORDINANCE PROHIBITING THE TYING AND PASTURING OF ALL KINDS OF ANIMALS AT THE BOTH SIDES OF THE NATIONAL ROAD FROM BARANGAY DENUYAN UP TO BARANGAY SOGUILON, SIAYAN, ZAMBOANGA DEL NORTE AND IMPOSING PENALTIES ANY VIOLATION THEREOF".


SECTION II. PROHIBITION: Tying and pasturing of all kinds of animals like carabao, horse, cow, goat and pig shall be prohibited in both sides of the road where there are growing fruit trees from barangay Denuyan to Soguilon.

SECTION III. PENALTY: Any person or group of persons who violate this Ordinance shall be penalized as follows:

1 st Attempt	- fine of P500.00/tree
2 nd Attempt	- fine of P1,000.00/tree
3 rd & succeeding violations	- fine of P1,500.00/tree and/or imprisonment of 3 to 5 months or both at the discretion of the Court.


SECTION IV. EFFECTIVITY CLAUSE. This ordinance shall take effect immediately upon approval.


