**"MUNICIPAL ORDINANCE NO. 14-12
Series of 2014**

AUTHORED BY HONORABLE FELIZARDO I. GAYAPA, SR.

PREFATORY

The indigenous people living in the municipality of Siayan, Zamboanga del Norte, part of the Zamboanga Peninsula, known as the subanen tribe have acquired the skill of making a native wine called "Gasi". It is made out of several plants/herbs with rice and cassava, sweet, and mellow, tasty, fermented and sealed in a jar. One can sip the wine through a small bamboo stick is called "hasam". Gasi drinking is a part of subanen culture and always indispensable in every gathering like birthdays, weddings, thanks giving, fiesta and other celebration.

Cognizance to this, "PANGASE" is taken from the word "Gasi" which necessitates a more grandeur celebration that is "Pangase Festival".

BE IT ORDAINED by the Sangguniang Bayan in session assembled, that:

SECTION I. TITLE. This Ordinance shall be known as "AN ORDINANCE DECLARING JUNE 16-17 AS THE OFFICIAL PANGASE FESTIVAL OF THE MUNICIPALITY OF SIAYAN, ZAMBOANGA DEL NORTE".

SECTION II. DEFINITION OF TERMS:

1. Pangase – a native wine of the subanen tribe.
2. Gasi – original word of Pangase.
3. Hasam – small bamboo stick for sipping Pangase wine.
4. Sealed – enclosed by any material as protection from insects.
- Keep it clean and sanitary.
5. Festival – a festivity of special occasion in any given community.
6. LGU – Local Government Unit.

SECTION III. ADMINISTRATIVE PROVISION: That the LGU of Siayan with the support of all component barangays of the municipality and schools shall hold yearly the Pangase Festival on the date mandated in this Ordinance.


SECTION IV. ACTIVITIES/SCOPE OF THE CELEBRATION: The festival shall showcase the following:

4. Street dancing and showdown
5. Native dances, musical contest and games


SECTION V. FUNDING: That the LGU Siayan shall allocate funding appropriation in the Annual Budget every year to defray various expenses for the celebration

SECTION VI. EFFECTIVITY CLAUSE. This ordinance shall take effect immediately upon approval.




