**"MUNICIPAL ORDINANCE NO. 14-13
Series of 2014**

PREFATORY STATEMENT

Almost all barangays in the municipality of Siayan are energized. Electric power is available day and night as a result many people put up and operate business establishments including Sing-Along thru Video Karaoke.

Sing-Along bars thru Video Karaoke and the like give delight the people not only in Poblacion, Siayan but also in many barangays of this municipality as a means of relaxation and enjoyment. However the noise and the very loud and uncontrolled volume of its sound cause disturbance to the classes in some schools and to the people living nearby.

The operation of Sing-Along thru Video Karaoke and the like need to be regulated so as not to disturb the public. As a rule only the time of operation and the volume or loudness of the musical instrument is hereby regulated.

SECTION I. TITLE – That this Ordinance shall be entitled as "AN ORDINANCE AMENDING SECTION II & III OF THE AMENDED MUNICIPAL ORDINANCE NO. 08-13, SERIES OF 2008, REGULATING THE OPERATION OF SING-ALONG THRU VIDEO KARAOKE AND THE LIKE ESTABLISHED WITHIN THE PUBLIC MARKET OF SIYAN, ZAMBOANGA DEL NORTE AND IN THE DIFFERENT BARANGAYS OF THIS MUNICIPALITY".

SECTION II. REGULATED ACTS – That the operation of Sing-Along thru Video Karaoke and the like are hereby regulated, as follows:

- TIME/DISTANCE LIMIT:**
- 1) That the Sing-Along bars thru Video Karaoke and the like operating in the residential areas shall stop or end at 9:00 O'clock in the evening and for those Sing-Along bars thru Video Karaoke established within the market area shall stop at 10:00 O'clock in the evening.
 - 2) That Sing-Along bars thru Video Karaoke and the like located within a distance of 70 meters from the school area shall not operate during days with classes from 7:00 O'clock A.M. up to 4:00 O'clock P.M.

- 3) During special occasions like Araw ng Siayan or Barangay Fiesta, Weddings, Birthdays and other special occasions where Sing-Along thru Video Karaoke is used for the affair, operators or the concerned owners may operate beyond the limit hour.

SECTION III. SEPARABILITY CLAUSE: That Ordinance No. 08-13 is hereby repealed.

SECTION IV: PENAL CLAUSE – Any operators who violates this Ordinance shall suffer a fine of not less than P1,000.00 but not more than P1,500.00 or an imprisonment of 5 days but not more than 10 days or both fines and imprisonment in the discretion of the Honorable Court.


SECTION V. EFFECTIVITY CLAUSE. This ordinance shall take effect immediately upon approval.


