"ORDINANCE NO. 00-014 Series of 2000

AN ORDINANCE REALIGNING THE AMOUNT OF P1,254,725.55 CONTINUING APPROPRIATIONS FOR PERSONAL SERVICES EMBODIED IN THE ANNUAL BUDGET CY 2000 AND THE SAME IS HEREBY MADE AVAILABLE FOR THE GRANT OF 10% SALARY INCREASE FOR THE OFFICIALS AND EMPLOYEES OF THE LOCAL GOVERNMENT UNIT AS PROVIDED FOR UNDER LBC NO. 69.

PREFATORY STATEMENT

With the intent of the Local Government to provide the privileges of the officials and employees with maximum salaries and wages authorized under LBC No. 69, realignment of some continuing appropriations of the same class expense embodied in the Annual Budget CY 2000 is made under Executive Order No. 2000-01 dated April 11, 2000 to augment for the grant of 10% salary increase. However the Hon. Sangguniang Panlalawigan of Zamboanga del Norte advice under SP Resolution No. 336 that realignment of funds should be enacted/authorized through an ordinance pursuant to Sec. 336 of RA 7160.

BE IT ORDAINED by the Honorable Sangguniang Bayan in session assembled:

SECTION 1. TITLE: This Ordinance shall be known as "An ordinance realigning the amount of P1,254,725.55 continuing appropriation for personal services embodied in the Annual Budget CY 2000 and the same is hereby made available for the grant of 10% salary increase for the officials and employees of the Local Government Unit."

SECTION II. ORDAINING CLAUSE: That the amount of P1,254,725.55 continuing appropriations in the personal services class expense of the approved Annual Budget CY 2000 are hereby realign and the same is hereby made available for expenditures, breakdown as follows:

1, Amelioration Assistance	P826,000.00
2.Lump sum	50,149.02
3.Leave Credits Monetization	354,576.53
4. Elective Officials Productivity	24,000.00
	P1,254,725.55

SECTION III. EFFECTIVITY CLAUSE: That this Ordinance shall take effect on January 1, 2000.
