PREFATORY STATEMENT

In compliance with Local Budget Circular No. 67 that authorized for the payment of per diem to the members and support staff of the PLEB, likewise Local Budget Circular No. 73 further clarified existing rules on the grant of compensation benefits to the members, the PLEB members of this municipality was allocated funds embodied in the Annual Budget in the amount of P100,000.00 for its honorarium and for maintenance and other operating expenditures (MOOE).

However, the term of the previous PLEB composition of this municipality has been expired effective June 30, 2007 therefore was required to be re-organized by the NAPOLCOM, and the new PLEB composition of this municipality is the following:


