**"APPROPRIATION ORDINANCE NO. 11-14
Series of 2011"**

PREFATORY STATEMENT

WHEREAS, the municipality is a recipient of the MRDP-APL2 Infrastructure Loan Proceeds amounting to TWENTY EIGHT MILLION TWO HUNDRED NINE THOUSAND TWO HUNDRED SIXTY NINE PESOS AND EIGHTY THREE CENTAVOS (PhP28,209,269.83);

WHEREAS, the LGU counterpart of the project cost is already available and accordingly deposited under the General Fund Budget of the 20% development fund;

WHEREAS, there is a need to pass an Appropriation Ordinance for the contract amount of TWENTY EIGHT MILLION ONE HUNDRED THIRTY NINE THOUSAND SEVEN HUNDRED SIX PESOS AND EIGHTY CENTAVOS (PhP28,139,706.80) as a requirement for the initial release of 50%;

BE IT ORDAINED, by the Sangguniang Bayan in session assembled:

SECTION I. TITLE: This shall be known as "AN APPROPRIATION ORDINANCE APPROPRIATING THE AMOUNT OF TWENTY EIGHT MILLION ONE HUNDRED THIRTY NINE THOUSAND SEVEN HUNDRED SIX PESOS AND EIGHTY CENTAVOS (PhP28,139,706.80) FOR THE REHABILITATION OF SITIO TAGUE, DATAGAN-MACASING FARM TO MARKET ROAD IN THE MUNICIPALITY OF SIYAN, ZAMBOANGA DEL NORTE".


SECTION III. DISBURSEMENTS BASED ON APPROPRIATION.

SECTION III. EFFECTIVITY. This Ordinance shall take effect upon approval.


