"ORDINANCE NO. 00-015 Series of 2000

AN ORDINANCE AMENDING CHAPTER II ARTICLE B, SECTION 2B.04 PARAGRAPH (e) OF THE MUNICIPAL ORDINANCE NO. 00-002 SERIES OF 2000 KNOWN AS THE MUNICIPAL REVENUE CODE OF SIAYAN, ZAMBOANGA DEL NORTE.

PREFATORY STATEMENT

Ordinance No. 002 was duly approved on June 8, 2000 revising the Municipal Ordinance No. 004 series of 1994 known as the Municipal Revenue Code and was declared in order for implementation by the Sangguniang Panlalawigan under SP Resolution No. 496 dated July 24, 2000.

However, in the process of implementation, some errors of omission were noted and if not corrected, the implication of the statement is deviated.

Chapter II, Article B Sec. 2b.04 par. (e) in the approved Municipal Revenue Code reads as follows:

"It shall be unlawful for the Municipal Treasurer or his/her representative to collect or accept payment of community tax from residence of this municipality or juridical person whose principal office is located in this municipality.

Supposedly, it should be stated as follows:

"It shall be unlawful for the Municipal Treasurer or his/her representative to collect or accept payment of community tax from non-residents of this municipality or juridical person whose principal office is not located in this municipality."

BE IT ORDAINED by the Honorable Sangguniang Bayan in session assembled:

SECTION 1. TITLE: This Ordinance shall be known as "An ordinance amending Chapter 11, Article B Section 2b.04 par. (e) of the Municipal Ordinance No. 00-002 Series of 2000 known as the Municipal Revenue Code of Siayan, Zamboanga del Norte."

SECTION II. AMENDMENTS: Chapter II Article B Section 2b.04 par. (e) states, "It shall be unlawful for the Municipal Treasurer or their representative to collect or accept payment of Community Tax from residence of this municipality, or juridical person whose principal office is located in this municipality."

Section 2b.04 par. (e) is hereby amended by insertion of the word "non" between the word "from" and "residence" and insertion of the word "not" between the word "is" and "located".

As amended Section 2b.04 par.(e) shall states, "It shall be unlawful for the Municipal Treasurer or their representative to collect or accept payment of Community Tax from non-residents of this municipality or juridical person whose principal office is not located in this municipality.

SECTION III. EFFECTIVITY CLAUSE: That this Ordinance shall take effect upon its approval.
