**"MUNICIPAL ORDINANCE NO. 16-01
Series of 2016**

PREFATORY STATEMENT

Republic Act 7160 (RA 7160) known as the Local Government Code of 1991 provides the taxing and other revenue-raising powers of the local government units. In conformance thereto, the local government unit of this municipality through the Office of the Sangguniang Bayan formulated Municipal Revenue Code under Ordinance No. 00-002, Series of 2000 and constantly updated every five (5) years for adjustment of taxes, fees, charges and other impositions and lastly it was revised under Municipal Ordinance No. 12-01, Series of 2012.

Further, RA 7160 empowered the local government Units to impose Secretary's/Documentary fees and charges to any person requesting copies of official records/documents from the different offices of the local government.

Secretary's fees had been imposed in the Local Government of this municipality authorized under Municipal Ordinance No. 12-01, Series of 2012 known as the Municipal Revenue Code, however, it was collected generally and no detailed description of documents by office hence this enactment.

BE IT ORDAINED BY the Sangguniang Bayan in session assembled:

SECTION I. TITLE. This shall be known as "MUNICIPAL REVENUE ORDINANCE IMPOSING SECRETARY'S/DOCUMENTARY SERVICE FEES AND CHARGES FROM THE DIFFERENT OFFICES OF THE LOCAL GOVERNMENT UNIT OF SIAYAN, ZAMBOANGA DEL NORTE AMENDING ARTICLE A, SECTIONS 110-112, CHAPTER IV OF MUNICIPAL ORDINANCE NO. 12-01, KNOWN AS THE MUNICIPAL REVENUE CODE".

SECTION II. IMPOSITION OF FEES AND CHARGES: There shall be collected the following Secretary's/Documentary service fees and charges from every person requesting for copies of official records/ documents from the offices of the Local Government Unit of this municipality at the following rates:

SECTION III. EXEMPTION. The fees and charges herein imposed shall not be collected for copies furnished to other offices and/or branches of the government for official business, except for those copies required by the Court at the request of the litigant, in which case, charges shall be in accordance with the above-mentioned schedule.

SECTION IV. TIME AND MANNER OF PAYMENT. The payments of fees and charges shall be made first to the Municipal Treasurer at the time of the request. The requesting party will present the official receipt prior the issuance of a copy of any municipal record or document from the respective offices.

SECTION V. APPLICABILITY CLAUSE. That this Ordinance is form-part of the Municipal Revenue Code of this municipality.


SECTION VI. REPEALING CLAUSE. That Sections 110-112, Article A, Chapter IV of Municipal Ordinance No. 12-01, Series of 2012, known as the Municipal Revenue Code is hereby repealed.


SECTION VII. PENALTY CLAUSE. That any violation of this ordinance both the employees and clients shall be penalized in the amount of P500.00 pesos and/or shall be sued for an administrative or criminal cases.

SECTION VIII. EFFECTIVITY. This Ordinance shall take effect upon approval of the Sangguniang Panlalawigan in the province of Zamboanga del Norte, publication in local circulation and posting of copies at three (3) conspicuous places.
