## "MUNICIPAL ORDINANCE NO. 16-03 Series of 2016

## PREFATORY STATEMENT

The effects of the long drought and dry spell such as the "EL Niño" greatly reduced the volume of water supplied by the water system level III maintained and operated by the Local Government Unit. There is a need that water bills shall be adjusted instead of the monthly minimum payment, it shall be based on the actual number of cubic meter consumed.

BE IT ORDAINED by the Sangguniang Bayan of Siayan, Zamboanga del Norte in session assembled, that:

SECTION I. TITLE: This Ordinance shall be known as "AN ORDINANCE AMENDING ARTICLE D AMENDING ARTICLE D, SECTION 160, (WATER TARIFF FOR LEVEL III WATER SUPPLY) CHAPTER V OF MUNICIPAL ORDINANCE NO. 12-01, KNOWN AS THE "MUNICIPAL REVENUE CODE".

# SECTION II. ADJUSTMENT OF WATER BILLS CHARGED TO THE CONSUMERS.

That in time of emergency wherein the water supply or volume of water supplied to the consumers greatly reduced due to the effects of long drought such as "El Niño", collection of charges and/or payments of water bills shall be based on the actual volume of water consumed by cubic meter.

SECTION III. AMENDING CLAUSE: That Article D, Section 160, Chapter V of Municipal Ordinance No. 12-01, charged a minimum of PHP154.00 per 10 cubic meters monthly to water consumers shall be amended, as follows:

That in time of water crisis, water bills shall be based on the actual number of cubic meter consumed at PHP 15.40 per cubic meter.

SECTION IV. ADMINISTRATIVE PROVISION: That in the event that the water supply will be backed to its normal volume and consumers will be satisfactorily served, water bills shall be charged to its usual obligation under Article D, Section 160 (Water Tariff for Level III Water Supply), Chapter V of Municipal ordinance No. 12-01, known as the Municipal Revenue Code.

SECTION V. EFFECTIVITY: That this Ordinance shall take effect upon approval
