Series of 2016

**PREFATORY STATEMENT**

**WHEREAS**, pursuant to Proclamation No. 1160, Series of 2015 which declare a National Day for Youth Celebration in Climate Action;

**WHEREAS**, the youth yearly celebration is in line with Section 16, Article II of the 1987 Constitution which provides that the state shall protect and advance the right of the people to a balanced and healthful ecology in accord with the rhythm and harmony of nature;

**WHEREAS**, the celebration of Youth Day in the municipality of Siayan is in consonance to R.A. No. 8044 or the "Youth in Nation-Building Act of 1995" which created the National Youth Commission to provide leadership in the formulation of policies and in setting directions of all youth promotions, development programs and activities;

**WHEREAS**, in conformance to these, May 2, 2016 and every year thereafter is declared as Youth Day Celebration in the Municipality of Siayan, Zamboanga del Norte;

**BE IT ORDAINED** by the Sangguniang Bayan of Siayan, Zamboanga del Norte in session assembled, that:

**SECTION I. TITLE:** This Ordinance shall be known as "AN ORDINANCE DECLARING MAY 2, 2016 AND EVERY YEAR THEREAFTER AS YOUTH DAY CELEBRATION IN THE MUNICIPALITY OF SIAYAN, ZAMBOANGA DEL NORTE".

**SECTION II. ORDAINING CLAUSE:** That every 2<sup>nd</sup> day of May every year is hereby declared as "Youth Day Celebration" in the municipality of Siayan, Zamboanga del Norte.

**SECTION III. ACTIVITIES.** That the intended youth celebration will focus and demonstrate strong advocacy on climate change and emphasize awareness and concern for environmental protection and conservation.


The celebration will also provide a venue for social, cultural development and unity among the youth of this municipality.

**SECTION IV. FUNDING SOURCE:** That all expenses incur during the celebration are chargeable against the capability building appropriation embodied in the Annual Budget of the local government unit.




**DECLARING IN ORDER AND OPERATIVE, ORDINANCE NO. 16-04, S. 2016



**"APPROPRIATION ORDINANCE NO. 16-05**  
Series of 2016

**PREFATORY STATEMENT**

**WHEREAS**, Section 8.0 of Local Budget Circular No. 108 dated February 24, 2016 of the Department of Budget and Management (DBM) provides the guideline for the grant of Mid-Year Bonus for all government personnel beginning FY 2016;

**WHEREAS**, the Municipal Government used to grant Mid-Year Bonus in previous years in a form of cash advance from the Year End Benefits appropriations equivalent to 50% of the monthly salary;

**WHEREAS**, in order to boost performance of personnel to surpass satisfactory service, the LGU intends to grant the usual incentive equivalent to one (1) month salary, provided that funds are available for the purpose from savings in PS appropriations from January to May, 2016;

**WHEREAS**, in case funds are insufficient, the bonus may be proportionately granted in percentage as computed by the Local Finance Committee;

**BE IT ORDAINED** by the Sangguniang Bayan in session assembled:

**SECTION I. TITLE** – This Ordinance shall be known as **"AN APPROPRIATION ORDINANCE GRANTING MID-YEAR BONUS EQUIVALENT TO ONE (1) MONTH SALARY TO ALL MUNICIPAL OFFICIALS AND EMPLOYEES OF THE LOCAL GOVERNMENT UNIT (LGU) WHETHER ELECTIVE, REGULAR PERMANENT OR TEMPORARY IN STATUS, AND TO THOSE CASUAL PLANTILLA CHARGEABLE AGAINST SAVINGS IN PERSONAL SERVICES (PS) APPROPRIATIONS FROM JANUARY TO MAY, 2016"**.

**SECTION II. FUNDING SOURCE** – The available savings in Personal Services (PS) appropriations from January to May, 2016.
