The Municipal Health Office (MHO) of the Local Government Unit of Siayan is in need of a permanent ambulance driver to carry patients to the hospitals for medical treatment.

The present ambulance drivers are only "detailed" to the Municipal Health Office (MHO) which their official positions are under the Mayor's Office as reflected in the Plantilla of Personnel of the LGU. To augment the existing manpower of the MHO and in the interest of a more efficient and effective health services, there is a necessity of position of driver in the said office. One (1) driver position in the Mayor's Office will soon be vacant by December 2016 due to mandatory retirement of the incumbent. Hence, the transfer of subject item.

Thus, one (1) Driver Position under the Mayor's Office be transferred to the Municipal Health Office including its appropriation in the Plantilla of Personnel effective January 1, 2017.

BE IT ORDAINED by the Honorable Sangguniang Bayan in session assembled, that:


SECTION I. TITLE: This Ordinance shall be known as "**AN ORDINANCE EFFECTING THE TRANSFER OF THE POSITION OF DRIVER I, ITEM # 1011-9 INCLUDING ITS APPROPRIATION IN THE PLANTILLA OF PERSONNEL UNDER MAYOR'S OFFICE TO THE OFFICE OF THE MUNICIPAL HEALTH OFFICER EFFECTIVE JANUARY, 2017**".


SECTION II. ORDAINING CLAUSE: That one (1) Driver Position of Driver I with Item #1011-9 including its appropriations in the Plantilla of Personnel under the Mayor's Office is hereby transferred to the Municipal Health Office effective January 1, 2017.

SECTION III. EFFECTIVITY CLAUSE: That this ordinance shall take effect effective January 1, 2017.
