**"MUNICIPAL ORDINANCE NO. 16-10**  
Series of 2016

AN ORDINANCE ESTABLISHING THE QUALITY CONTROL OF RAW RUBBER PRODUCTS OF THE MUNICIPALITY OF SIAYAN, ZAMBOANGA DEL NORTE AND IMPOSING PENALTY THEREOF.

BE IT ORDAINED, by the honorable Sangguniang Bayan of Siayan, Zamboanga del Norte in a session assembled:

**SECTION 1.** This ordinance shall be known as **"THE RAW RUBBER QUALITY CONTROL ORDINANCE"**.

**SECTION 2.** This ordinance covers all raw rubber products of farmers throughout the municipality of Siayan, Zamboanga del Norte, including all raw rubber products coming from other areas beyond the territorial jurisdiction of this municipality which will be brought for marketing purposes.

**SECTION 3. Administrative Provision:** All raw rubber products brought for marketing purposes in the municipality of Siayan, shall be those that contain the best quality only. No other foreign elements and or materials mixed or inserted into the rubber lump. The coagulation process shall conform with the accepted rules and regulations.

**SECTION 4. Rules and Regulations:** The following Rules and Regulations shall be strictly observed in the conduct of Buying and Selling of Raw Rubber Products;

**4.1.** Raw Rubber Lump brought to any buying Station of this municipality shall undergo strict examination to determine the chemical contents of the product based on the process of coagulating the rubber latex. Should the product containing Battery Solution or any harmful chemicals used as coagulating medium, the rubber lump shall be rejected.

4.2 Only those rubber lumps which coagulated with the use of Formic Acid, or through natural way of coagulation the product shall be accepted, and be sold based on the prevailing market price.

4.3 Rubber Lumps which were coagulated with the use of a battery solution shall be denied entry to any buying station of this municipality.

4.4 Only duly licensed Rubber Canvassers, Brokers, Agents, and Buyers with calibrated weighing scales are permitted to engage business in the Municipality of Siayan.

4.5 Duly licensed Rubber Canvassers, Brokers, Agents, and Buyers shall be duly accredited by the municipality through Mayor's Permit issued by the Municipal Mayor's Office.

**SECTION 5. Prohibition:** Rubber Farmers/Producers/Tapers/Buyer/Brokers and other persons responsible in handling the raw rubber products are enjoined to observe the following prohibitions:

5.1 Using of Battery Solution as coagulating medium is strictly prohibited.

5.2 Insertion of other elements such as stone, sand and gravel, soil, bags of water and the like to increase the weight of the rubber lumps are intolerable.

5.3 Agents/Buyer and Brokers are strictly prohibited to purchase rubber in the municipality of Siayan not complying with the provision of this raw rubber products quality control ordinance.

**SECTION 6. Penal Provision.** Willful violation on the part of the Farmers/Producers/Tapers/Agents/Buyers/Brokers against the provision of this ordinance shall be subject to the following penalties, to wit:

Second	Fines	500.00	1,000.00
Third	Fines	1,000.00	2,000.00

6.2 On the part of the Buyer/Broker Fine and Revocation of business license or permit after the third and final offense shall be imposed.

**SECTION 7. Separability Clause:** Should any part of this ordinance be declared unconstitutional or illegal to any existing laws and the other parts not declared shall remain in full force and effect.

**SECTION 8. Supplementary Clause:** On matters not provided in this ordinance, or any existing applicable laws and their corresponding implementing rules and regulations, executive order and relevant issuance issued therefore shall be applied in a supplemental manner.

**SECTION 9. Repealing Clause:** All ordinances, executive orders and administrative issuances or part/s thereof which are inconsistent with this ordinance are hereby repealed or modified accordingly.

**SECTION 10. Effectivity:** This Ordinance shall take effect immediately after thirty (30) days following the completion of its full publication in any newspaper circulating in the Municipality of Siayan, Zamboanga del Norte, and posting at the Bulletin Board of the Municipality in compliance with Section 511 of the Local Government Code.




