AN ORDINANCE MAKING AVAILABLE THE AMOUNT OF FOUR HUNDRED THOUSAND (P400,000.00) PESOS FROM THE 20% DEVELOPMENT FUND CY 2001 AS COUNTERPART OF THE LOCAL GOVERNMENT UNIT FOR THE COST OF LABOR FOR THE CONSTRUCTION AND COMPLETION OF WAREHOUSE BASED ON THE TOTAL LABOR COST ESTIMATE SUBMITTED BY THE NFA.

PREFATORY STATEMENT

The municipality of Siayan is a recipient of ERAP Food Security Warehouse from the national government through the National Food Authority, Dipolog City. This project is a cost-sharing scheme between the NFA and the Local Government Unit under a Memorandum of Agreement (MOA) in which the Local Government Unit have a counterpart in the amount of P400,000.00 for the cost of labor.

BE IT ORDAINED by the Honorable Sangguniang Bayan in session assembled:

SECTION I. TITLE: This Ordinance shall be known as "An Ordinance Making Available the Amount of Four Hundred Thousand Pesos (P400,000.00) as Counterpart of the Local Government Unit for the Cost of Labor for the Construction and Completion of Warehouse.


SECTION II. ORDAINING CLAUSE: That the amount of P400,000.00 pesos is hereby made available from the 20% DF CY 2001 as counterpart fund for the cost of labor for the construction and completion of Warehouse to be established in this municipality.


SECTION III. EFFECTIVITY CLAUSE: That this Ordinance shall take effect on January 1, 2001.


