## "APPROPRIATION ORDINANCE NO. 11-16 Series of 2011

## PREFATORY STATEMENT

In the preparation of the Annual Budget FY 2011, the counterpart fund for implementation of projects in form of grant and/or assistance from outside sources has been provided and incorporated therein. However due to the willingness of the local government unit of this municipality to avail the 2<sup>nd</sup> Cycle of the KALAHI-CIDSS::MT projects of the DSWD and DILG, some requirements shall be complied particularly the appropriations for its counterpart to be separated for exclusiveness of its usage, therefore transferring of funds from the general fund into trust: funds shall be emphasized hence this enactment.

BE IT ORDAINED by the Sangguniang Bayan in session assembled:

SECTION I. TITLE: This shall be known as "AN APPROPRIATION ORDINANCE ALLOICATING THE AMOUNT OF ONE MILLION NINE HUNDRED EIGHTY THOUSAND PESOS (P1,980,000.00) AS MINIMUM LOCAL CASH COUNTERPART OF THE KALAHI-CIDSS:MT PROJECT".

# SECTION II. STATEMENT OF AVAILABILITY OF FUNDS.

#### SOURCE OF FUNDS:

P700,000.00 — Continuing Appropriation – 1011-20%–300-231 – Water Workss 217,000.00 — Continuing Appropriation – 1011-20%-200-851 – FMR 467,593.00 — Current Appropriation – 1011-20%-200-852-FMR 300,000.00 — Current Appropriation – 1011-20%-200-851-FMR 200,000.00 — Current Appropriation – 7611-20%-200-969-1 295,407.00 — Current Appropriation – 1011-20%-854 P1.980,000.00

SECTION III. ORDAINING CLAUSE. That the amount of ONE MILLION NINE HUNDIRED EIGHTY THOUSAND PESOS (P1,980,000.00) from the General Fund is hereby allocated and transferred imto Trust Fund representing the 60% of the 30% local contribution counterpart in the implementation of KALAHI-CIDSS:MT Project.

SECTION IV. EFFECTIVITY. That this Ordinance shall take effect upon approval.
